2 improvement district no. 133 for the improvement of NE

5 **STATEMENT OF FACTS**

6 1. Pursuant to King County Motion 12759, a public hearing was held on  
7 June 9, 2008, on the petitions of property owners within the district to  
8 dissolve the road improvement district created to improve certain streets.

9 2. Notice of the hearing was duly published and mailed to each property  
10 owner pursuant to the requirements of RCW 36.88.050.

11 3. All written and verbal protests were considered.

12 4. It is hereby found that the petitions, including all additions thereto and  
13 withdrawals there from made prior to 5:00 p.m. of the business day before  
14 the hearing, are sufficient.

15 5. It is further found that all requirements of RCW 36.88.050 and King  
16 County Motion 12759 have been satisfied.

17 **BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:**

18            SECTION 1. There is hereby dissolved a road improvement district in King  
19 County known and designated as “King County road improvement district no.133” (“RID  
20 133”), as created by King County council Ordinance 15058. The district includes all the  
21 territory shown in Attachment A to this ordinance - RID 133 Boundary Map.

22            SECTION 2. It is hereby found that the plan for improvement and construction of  
23 RID 133 is not feasible due to increased costs associated with necessary public safety  
24 improvements and for compliance with subsequent environmental and storm water  
25 regulations, in that the costs to property owners within the district would be overly  
26 burdensome, and that the cost of the improvement exceeds the benefits to be derived  
27 from the improvement by the properties in RID 133.

28            SECTION 3. The director of the department of transportation is hereby  
29 authorized and directed to tabulate costs and expenses for preliminary engineering and  
30 administration in conjunction with the work done to date. The director is further  
31 authorized and directed to recover costs and expenses for this project from the RID  
32 guaranty fund.


33            SECTION 4. The assessment roll for RID 133, set at \$461,066.94 total, or  
34 \$5,361.24 per property, is hereby rescinded in full. All liens and encumbrances  
35 associated with RID 133 shall be removed from the subject properties.

36            SECTION 5. It is the intention of the King County council that any costs incurred  
37 to date for preliminary engineering and right-of-way acquisition will be applied to any  
38 road improvement district created in the future for the improvement of any portion of an  
39 improvement included in RID 133 to the extent such costs are for work that benefits such  
40 later improvements.


Ordinance 16131 was introduced on 5/12/2008 and passed by the Metropolitan King County Council on 6/9/2008, by the following vote:



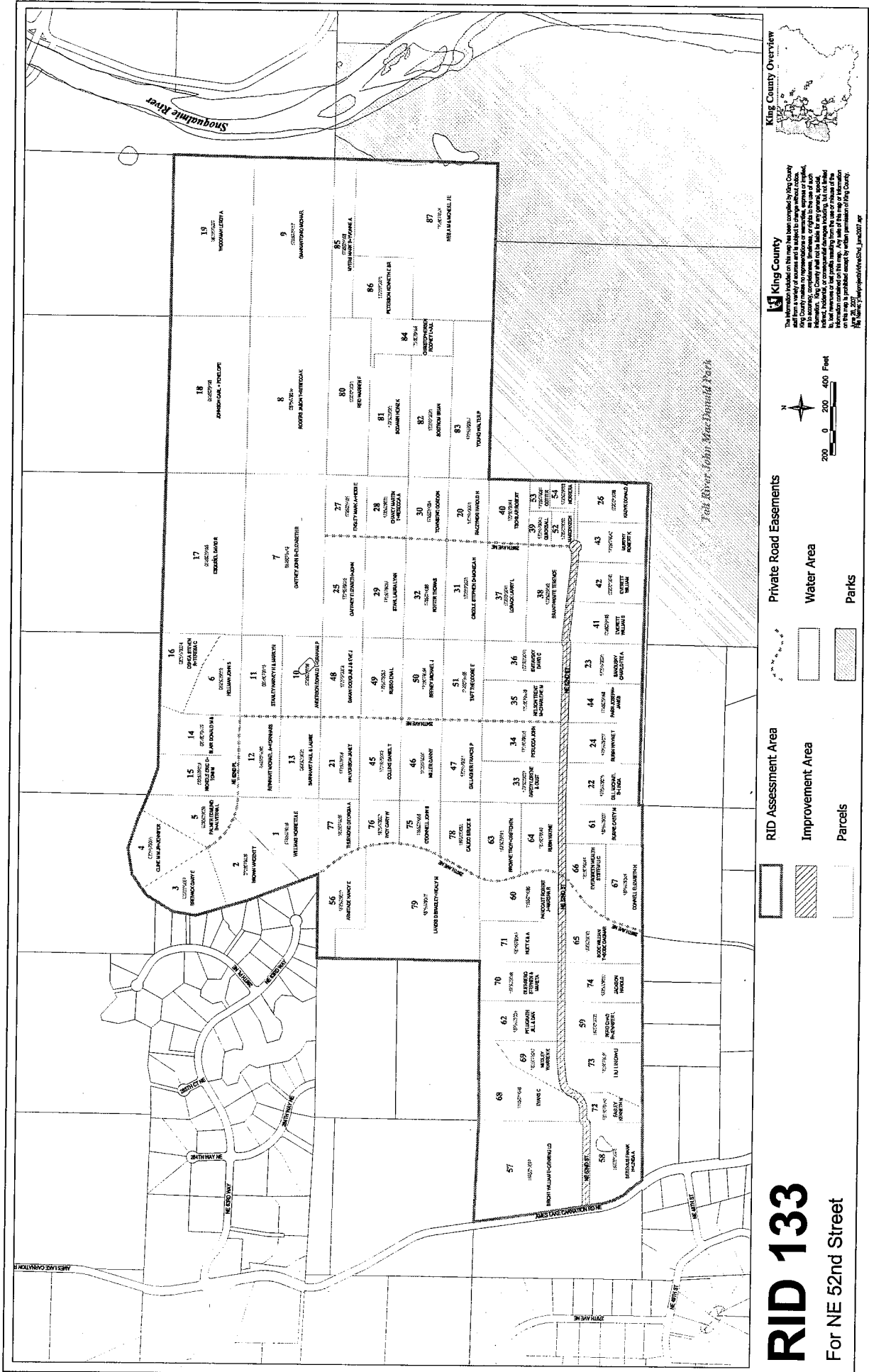
