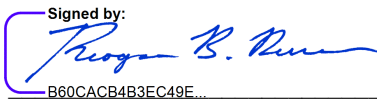

**FIRST AMENDMENT TO
CONTRACT FOR LEGAL CONSULTING SERVICES
KING COUNTY FLOOD CONTROL ZONE DISTRICT**

THIS AMENDMENT amends Sections 4 of the Contract for Legal Consulting Services ("Contract") between the King County Flood Control Zone District, King County, Washington, a municipal corporation of the State of Washington ("District") and Inslee, Best, Doezie & Ryder, P.S. ("Legal Consultant"), as follows:

A. Amendment of Section 4. Effective August 1, 2026, Section 4 of the Contract is amended as follows:

1. Duration of Agreement. This Agreement shall be in force and effect for a period commencing on August 1, 2026, and ending July 31, 2027, unless sooner terminated or extended under the provisions of this Agreement. Time is of the essence of this Agreement in each and all of its provisions in which performance is required.
