NOTICE IS HEREBY GIVEN that a Notice of Intention has been filed with the King County Council relating to the annexation of approximately 205.3 acres of land into King County water district 119, known as the Oppen Annexation, for the purpose of water service. A public hearing before the Metropolitan King County Council is to be held in Room 1001, King County Courthouse, on Wednesday, September 25, 2019 at 9:30 a.m.

A description of the proposed area to be annexed is as follows:  
A portion of Sections 10 and 15, Township 26 North, Range 7 East of the Willamette Meridian, King County, Washington; more particularly described as follows:

The east 495 feet of the of the southwest quarter of the southwest quarter of Section 10, Township 26 North, Range 7 East of the Willamette Meridian, King County, Washington;  
Except the north 505 feet thereof; And the south 815 feet of the west 75 feet of the southeast quarter of the southwest quarter of said Section 10;

Together with the north half of the southwest quarter and the west half and the southeast quarter of the northwest quarter of Section 15, Township 26 North, Range 7 East of the Willamette Meridian, King County, Washington.
