A MOTION confirming the appointment of Ross Marzolf, as a representative of the registered voters of King County who are not representatives of any of the groups who are represented on the committee, to the King County citizens' elections oversight committee.

Mike Alvine, Council Staff, briefed the committee and introduced Ross Marzolf, appointee to the King County Citizens' Elections Oversight Committee. Mr. Marzolf answered questions from the members.

Councilmember Hague moved the motion. Ms. Hague moved Amendment 1. clarifying who Mr. Marzolf represents on the Citizens' Elections Oversight Committee. #### 8. **Proposed Ordinance No. 2008-0415**

#### **Play Video**

AN ORDINANCE making a supplemental appropriation of \$83,973,548 to the office of information resource management capital project fund to implement the Accountable Business Transformation capital project; and amending the 2008 Budget Ordinance, Ordinance 15975, Section 130, as amended, and Attachment B, as amended.

Councilmember Gossett moved Proposed Ordinance 2008-0415.

Councilmember Ferguson moved Amendment 1, which inserts new Attachment A that reduces project contingency from 30 % to 20 %, dated 10/1/08. Amendment 1 passed 8-0 with Councilmember von Reichbauer excused.

Councilmember Ferguson moved Amendment 4, which adds language restricting major allocations of project contingency until such a time as the CPO office and Council have had a chance to review changes. Amendment 4 passed 8-0 with Councilmember von Reichbauer excused.

Councilmember Ferguson moved Amendment 5, which adds language requiring the benefits realization plan to be transmitted by April 30, 2009. Amendment 5 passed 8-0 with Councilmember von Reichbauer excused.

Councilmember Phillips moved Amendment 6, which adds language requiring transmittal of the policies, procedures and training records regarding employee interactions with the consultant. Amendment 6 passed 8-0 with Councilmember von Reichbauer excused.

Councilmember Phillips moved Amendment 7, which adds language requiring review by the Chief Civil Deputy Prosecuting Attorney. Amendment 7 passed 8-0 with Councilmember von Reichbauer excused.

Councilmember Phillips moved Amendment 8, which adds language requiring certification by the manager of the office of capital project oversight to the access to program records. Amendment 8 passed 8-0 with Councilmember von Reichbauer excused.

Councilmember Phillips moved Amendment 9, which adds reporting requirements for an annual and quarterly report. Councilmember Lambert offered a friendly amendment changing the date in Section 3 from January 1 to March 1. Amendment 9 passed 8-0 with Councilmember von Reichbauer excused.

Councilmember Phillips moved a Title Amendment which corrects the title to reflect a 20% project contingency. The Title Amendment passed 8-0 with Councilmember von Reichbauer excused.

A motion was made by Mr. Gossett that this matter be Recommended Do Pass Substitute. The motion carried by the following vote:
