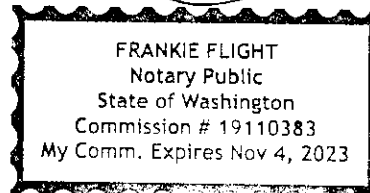

NOTICE IS HEREBY GIVEN, that a public hearing before the Metropolitan King County Council will be held at the King County Courthouse, 516 3rd Avenue Room 1001 on the 28th day of March, 2023, at 1:00 p.m. to consider adoption of Proposed Ordinance 2023-0089, concerning adoption of a no shooting area near the City of Black Diamond. It is expected that the Council will take action on this Proposed Ordinance at the March 28, 2023, meeting following the public hearing.

SUMMARY:

The Proposed Ordinance would establish a second no shooting area within Crow voting precinct in south King County and amending King County Code (K.C.C.) chapter 12.68. The area is described as:

Those portions of Township 21 North, Range 7 East, W.M. comprised of the northeast and northwest quarters of Section 8 and the east half of the northeast quarter of Section 7.
A map is attached as Attachment C to Proposed Ordinance 2023-0089.

In unincorporated King County, residents may discharge firearms on their own property, or with the permission of the property owner, unless a no shooting area has been established by ordinance if the council finds the petitioned area to be beneficial to the public health, safety and general welfare under the requirements of K.C.C. chapter 12.68.010. Violations of no shooting areas are defined under K.C.C. 12.68.020 and constitute a misdemeanor, with the first offence shall constitute a civil penalty not to exceed one hundred dollars, and consecutive offenses punishable by a fine of up to two hundred fifty dollars or no more than ninety days in jail.
