1	AN ORDINANCE relating to the addition of
2	approximately 83.85 acres to Soos Creek Water and Sewer
3	District for the purpose of providing sewer service for
4	future development.

7	STATEMENT OF FACTS:
8	1. A notice of intention proposing the addition of approximately 83.85
9	acres to Soos Creek Water and Sewer District for the purpose of
10	providing sewer service for future development was filed with the county
11	council effective December 18, 2003.
12	2. Soos Creek Water and Sewer District has found the petition for
13	transfer to be sufficient and has concurred with the proposed transfer in
14	Resolution No. 2481-S, passed on July 16, 2003.
15	3. Soos Creek Water and Sewer District filed a Determination of
16	Nonsignificance on the proposed annexation dated July 16, 2003.
17	4. The utilities technical review committee recommended county council

18	approval of the proposed annexation.
19	5. The county council held the legally required public and has considered
20	the criteria in RCW 57.02.040.
21	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
22	SECTION 1. The addition of approximately 83.85 acres to Soos Creek Water and
23	Sewer District for the purpose of providing sewer service for future development
24	described in Attachment A to this ordinance is approved. This proposed annexation is
25	consistent with RCW 57.02.040.
26	SECTION 2. Soos Creek Water and Sewer District is the appropriate entity to
27	serve the area proposed to be annexed.
28	SECTION 3. Completion of this annexation does not constitute county approval

or disapproval of any other permits, certifications or actions necessary to provide service to this annexation area.

## SOOS CREEK WATER & SEWER DISTRICT RESOLUTION NO. 2481-S

#### ANNEXATION NO. P-360S LEGAL DESCRIPTION

A description of the area to be annexed is as follows:

Beginning at the northeast corner of Government Lot 1 lying within the Northwest quarter of Section 19, Township 22 North, Range 6 East, Willamette Meridian, in King County, Washington, said point lies on the existing Soos Creek Water and Sewer District boundary and also the Point of Beginning; Thence easterly along the north line of said Section 19 to the northeast corner of the Northwest quarter of said Section 19:

Thence southerly along the east line of the Northwest quarter of said Section 19 to its intersection with the southerly right-of-way line of Southeast Wax Road;

Thence southwesterly along the southerly right-of-way line of said Wax Road to its intersection with the south line of the Northwest quarter of said Section 19;

Thence westerly along the south line of the Northwest quarter of said Section 19 to the northeast corner of Government Lot 3 of said Section 19, also being the northeast corner of Shadow Glen as recorded in Volume 107 of Plats at Pages 44 and 45, records of King County Washington, said point lying on the existing Soos Creek Water and Sewer District boundary;

Thence northerly along the east line of Government Lot 2 of said Section 19 to the northeast corner of said Government Lot 2;

Thence westerly along the north line of said Government Lot 2 to the east line of the west half of Government Lot 1 of said Section 19;


Thence northerly along said east line, also known as the west line of Shortridge Park as recorded in Volume 69 of Plats at Pages 8 and 9, records of King County, Washington, to the north line of Government Lot 1 of said Section 19;

Thence easterly along said north line to the Point of Beginning.
