NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse (516 Third Avenue, Seattle, WA) on Wednesday, August 21, 2019, beginning at 10:30 AM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2019-0143 (Ordinance 19034) an ordinance relating to the 2019 periodic review of the shoreline master program. Following the Department of Ecology's review, the Council then adopted this Ordinance at the Wednesday, December 4, 2019 meeting.
