1 AN ORDINANCE making an honorary road name  
2 designation in recognition of Mukai Farm and Garden.

3 **STATEMENT OF FACTS:**

4 1. The council, by motion, may propose an honorary road name  
5 designation, consistent with K.C.C. 16.08.060.

6 2. On April 6, 2021, the council passed Motion 15856, which proposed an  
7 honorary road name designation in recognition of Mukai Farm and  
8 Garden.

9 3. Before World War Two, the Mukai Farm & Garden was one of the  
10 largest strawberry farms in America.

11 4. The farmstead was once a hub of Japanese American social and  
12 cultural life on Vashon Island.

13 5. The Mukai Agricultural Complex was designated a King County  
14 Landmark in 1993.

15 6. Kuni's garden, designed by Kuni Mukai in 1932, is the first Japanese-  
16 inspired stroll garden in the United States designed by an Issei woman.

17 7. Kuni's Garden received the 2020 John Spellman award for garden  
18 restoration.

19 8. The Mukai Cold Process Barreling Plans played a significant role in  
20 developing innovative processing and canning practices that helped

21 revolutionize the fruit business in the United States.

22 9. The Mukai Farm & Garden symbolizes the vibrant role of Japanese

23 Americans in Vashon's pre-World War Two agricultural economy.

24 10. The Mukai Farm & Garden continues to educate and engage the

25 people of King County about Asian American history and culture.

26 11. To honor the Mukai family and the broader Japanese American

27 immigrant community to 20th-century agriculture, business and

28 community life on Vashon Island, the council of King County is making

29 an honorary street designation of "Mukai Way" for 107th Avenue SW

30 from SW Bank Rd south to terminus of the road.

31 12. All requirements set forth in K.C.C. 16.08.060 regarding honorary

32 road name designations have been met.

33 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

34 SECTION 1. The section of 107th Avenue SW from SW Bank Rd south to

35 terminus of the road is given the honorary road name designation "Mukai Way" to honor

36 the contributions of the Mukai family and the broader Japanese American immigrant

37 community to 20th-century agriculture, business and community life on Vashon Island.

38 SECTION 2. The department of transportation, roads services division, shall

39 design, erect and maintain a properly engineered honorary road name sign reading as

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after signing session and, if you elect to create a DocuSign signer account, you may access them for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

### **Consequences of changing your mind**

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. To indicate to us that you are changing your mind, you must withdraw your consent using the DocuSign 'Withdraw Consent' form on the signing page of a DocuSign envelope instead of signing it. This will indicate to us that you have withdrawn your consent to receive required notices and disclosures electronically from us and you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.
