1 A RESOLUTION identifying the King County board of
2 health's selected nonelected member candidates to begin
3 serving in 2024.

4 WHEREAS, in accordance with R.C.W. 70.05.035, the King County board of
5 health shall have an equal number of elected to nonelected members, with one of the
6 nonelected members to be selected by the American Indian Health Commission for
7 Washington State, and the remaining members selected by the King County board of
8 health from three specific categories of interests: public health, health care facilities, and
9 providers; consumers of public health; and other community stakeholders, and

10 WHEREAS, as a result of vacancies, the King County board of health has
11 conducted a recruitment, selection, and appointment in accordance with chapter 246-90
12 WAC, BOH chapter 2.04, and K.C.C. chapter 2.35, and

13 WHEREAS, the King County board of health has selected applicants who will
14 represent community stakeholders to enhance the board's efforts to preserve and protect
15 the public's health;

16 NOW, THEREFORE, BE IT RESOLVED by the Board of Health of King
17 County:

18 A. The board of health recommends Christopher Archiopoli, to serve as a
19 representative of community stakeholders, for a three-year term to expire on December
20 31, 2026.

21 B. The board of health recommends Francoise Milinganyo, to serve as an
22 alternate representative of community stakeholders, for a three-year term to expire on
23 December 31, 2026.

24 C. The candidates selected by the board were recruited and selected in
25 accordance with chapter 246-90 WAC pertaining to Local Board of Health Membership
26 and each candidate selection meets the qualifications and requirements of RCW
27 70.05.035(1)(a).

28 D. In accordance with K.C.C. 2.35.024, the board will transmit to the King
29 County council this resolution along with the biography and application materials for



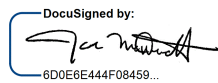

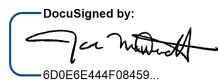
