8 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

9 SECTION 1. Ordinance 14262 , Section 8, as amended, and K.C.C. Chapter 3.32
10 hereby amended to read as follows:

11 **Parking fee revenues - disposition.** All revenues derived from parking fees shall
12 be distributed as follows:

13 ~~((All parking revenues derived from the increase of parking rates for covered and~~
14 ~~uncovered parking effective on or after January 1, 1989, shall be reserved for the support of~~
15 ~~health and human services activities and shall be deposited in the children and family set-~~
16 ~~aside fund. All revenue derived from elimination of free public parking shall be deposited~~
17 ~~in the current expense fund. Increased revenues derived from the increase of parking rates~~

18 ~~effective on or after January 1, 2002, shall be reserved for capital improvements to parking~~
19 ~~facilities and for the children and family set aside fund.))~~

20 A. Forty-four percent of parking revenues shall be distributed to the children and
21 family set aside fund for support of health and human services activities and the
22 remainder shall be distributed to the current expense fund;

23 B. It is the intent of the council to annually, during the budget process, identify a
24 portion of the revenue going to the current expense fund to be transferred to the major
25 maintenance reserve fund to support major maintenance projects at the garage and other
26 parking facilities, taking into account the major maintenance model and financial plan;

28 C. The department of executive services, facilities internal service fund shall be


29 reimbursed by the current expense fund for expenses associated with the operation of the
30 parking program.


Ordinance 14639 was introduced on 4/28/2003 and passed by the Metropolitan King County Council on 5/12/2003, by the following vote:
