Sponsors

1 A RESOLUTION relating to the Green River System-Wide
2 Improvement Framework; directing the King County
3 Director of Water and Land Resources to submit the Green
4 River System-Wide Improvement Framework SWIF to the
5 United States Army Corps of Engineers.

6 WHEREAS, the King County Flood Control District ("the District") passed
7 Resolution FCD2016-05.2 in February 2016 directing the King County Director of Water
8 and Land Resources to submit the Interim Green River System-Wide Improvement
9 Framework ("SWIF") to the United States Army Corps of Engineers ("USACE"), and

10 WHEREAS, the Interim SWIF Plan Acceptance was received by USACE
11 headquarters on March 31, 2017, and

12 WHEREAS, the USACE acceptance of the Interim SWIF granted temporary
13 rehabilitation eligibility under the USACE's P.L.84-99 program until March 31, 2019,
14 and

15 WHEREAS, the two-year extension was granted to the District, as levee sponsor,
16 to finalize the SWIF plan and begin implementation activities identified in the SWIF
17 Interim Report, and

18 WHEREAS, King County Water and Land Resources ("WLR"), as service
19 provider to the District completed the development of the SWIF Implementation Plan to

20 meet the final requirements of the SWIF process to address levee deficiencies and
21 system-wide issues, and

22 WHEREAS, SWIF implementation will occur over a twelve-year period from
23 2016-2028, during this period the District will submit annual progress reports to
24 demonstrate accomplishments to optimize flood risk reduction;

25 NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF
26 SUPERVISORS OF THE KING COUNTY FLOOD CONTROL ZONE DISTRICT:

27 SECTION 1. The District directs the director of King County water and land
28 resources division to submit the System-Wide Improvement Framework Plan March

29 2019, Attachment A to this resolution, to the United States Army Corps of Engineers for
30 acceptance.


