State Governor's Decla-

amended) regarding the
Open Public Meetings
Act on Tuesday, June 9,
2020 beginning at 1:00
PM. The purpose of this
public hearing was to
consider adoption of
Proposed Ordinance
2020-0032 (Ordinance
19119) an ordinance re-
lating an alternative
housing demonstration
project in North Highline
and the Vashon Rural
Town. The Council then
adopted this Ordinance
at the Tuesday, June 23,
2020 meeting.

SUMMARY:

Ordinance 19119 adopt
an alternative housing
demonstration project for
375 properties in the
White Center neighbor-
hood of North Highline
and two properties in the
Vashon Rural Town. The
demonstration project
will compare at least two
alternative housing op-
tions and their ac-
cessibility for popula-
tions who unable to find
suitable housing. A re-
port by the Executive
that describes and
evaluates preliminary re-
sults and provides rec-
ommended changes that
should be made to
county processes and
development regula-
tions.
