1	AN ORDINANCE approving the Northwest Water	
2	Systems Satellite Management Agency Plan, Amended	
3	March 24, 2011.	
4	STATEMENT OF FACTS:	
5	1. King County has adopted K.C.C. chapter 13.24, which requires	
6	approval of comprehensive plans for water utilities that distribute or obtain	
7	water in unincorporated King County as a prerequisite for operating in	
8	unincorporated King County, receiving approval for annexation proposals,	
9	being granted right-of-way franchises, and being given approval for right-	
10	of-way construction permits. K.C.C. 13.24.060 prescribes the	
11	requirements for approval of such plans, including consistency with state	
12	and local planning requirements.	
13	2. Northwest Water Systems has not yet had a plan approved by King	
14	County. Active in other areas of the state, the purveyor is interested in	
15	establishing a presence in King County.	
16	3. Northwest Water Systems has adopted a Satellite Management Agency	
17	Plan.	
18	4. King County has adopted a comprehensive plan that includes water	
19	supply policies in its provisions for facilities and services (policies F-201	

20	through F-244) that call for consistency with other adopted plans, support
21	for regional water supply planning, pursuit of reclaimed water, water
22	conservation and protection of water resources.
23	5. K.C.C. chapter 13.24 requires the utilities technical review committee
24	("UTRC") to review and make a recommendation to the King County
25	executive and council on the plan and the requirements under K.C.C.
26	chapter 13.24 and consistency with the King County Comprehensive Plan.
27	The UTRC has reviewed the planning data and company operations and
28	found the plan is consistent with pertinent county adopted plans and
29	policies.
30	6. The Washington state Department of Health's approval of the plan is
31	pending King County council action.
32	7. Approval of the plan is exempt under the state Environmental Policy
33	Act.
34	8. The Northwest Water Systems plan meets multiple existing statutory,
35	administrative and planning standards. As Northwest Water Systems'
36	operations, facilities and planning meet the requirements of the K.C.C.,
37	and are consistent with the King County Comprehensive Plan, the UTRC
38	recommends approval of the plan.
39	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
40	SECTION 1. The Northwest Water Systems Satellite Management Agency Plan,

- 42 satellite management agency plan.
