Ms. Patterson reported on the Sound Transit Executive Committee . The Committee heard an update from Sound Transit's CEO regarding the effects the federal sequester will have on Sound Transit. She commented on a presentation the members heard on the ORCA card, indicating that seven transportation agencies in the region are using the card to collect fares. Two of the seven agencies are Sound Transit and Metro, and she indicated that Metro boardings currently account for about 66 percent of all boardings.

Ms. Patterson also reported on the National Association of Counties' 2013 Legislative Conference in Washington, DC. She indicated there was an extraordinary report of information to county officials, and her primary focus was issues relating to the health committee. She offered information she had available for anyone that was interested.

Ms. Lambert also reported on the NATO Conference, indicating how worthwhile it was to attend and make contacts with so many people. She attended meetings relating to law and justice and cybersecurity, and briefed the Council on the main issues and focus.
