SUMMARY

The King County Council will consider Proposed Ordinance 2012-0136, authorizing the Executive to convey these facilities and property interests, which were owned and/or operated by King County prior to annexation by the City of Bellevue. They are being transferred as they serve annexing areas; the city agrees to assume full and complete responsibility for the operation, maintenance, repairs, and any subsequent improvements to the properties, property interests and facilities.
