A public hearing will be held before the King County Hearing Examiner, on the Twelfth Floor - in the Fred Conference Room, of the King County Courthouse, 516 - 3rd Avenue, Seattle, WA 98104 on Monday, March 26, 2018 at 1:00 pm or soon thereafter.

NOTE: If the Seattle School District announces a district-wide school closure due to adverse weather conditions or similar area emergency, the public hearing on this matter will be postponed. The area to be vacated is described as follows:

All those portions of the 156th Avenue SE and SE 300th Street rights-of-way, as dedicated to King County in the Plat of Soos Creek Five Acre Tracts, recorded in Volume 13, of Plats, on Page 59, records of King County, Washington, located in the Northwest quarter of the Southeast quarter of Section 2, Township 21 North, Range 5 East, Willamette Meridian, King County, Washington, and lying southerly and westerly of the B.N.R.R. right-of-way.

Containing an area of 26,362 square feet, more or less. The adjacent parcels are zoned RAS.
