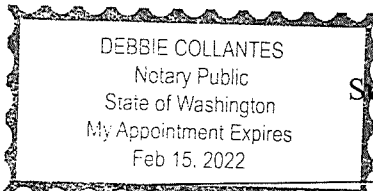

NOTICE IS HEREBY GIVEN that a Notice of Intention has been filed with the King County Council relating to the annexation of approximately 199.32 acres of land into the King County water district No. 119, known as the CanDoo Annexation, for the purpose of water service. A public hearing before the Metropolitan King County Council is to be held in Room 1001, King County Courthouse, on Wednesday, May 29, 2019, at 10:30 a.m.

A description of the proposed area to be annexed is as follows:
The east half of the Northeast Quarter of Section 34, Township 26 N., Range 7 East of the Willamette Meridian.

Together with;

The west half of the Northwest Quarter and the north half of the west half of the Southwest Quarter of Section 35, Township 26 N., Range 7 East of the Willamette Meridian.
