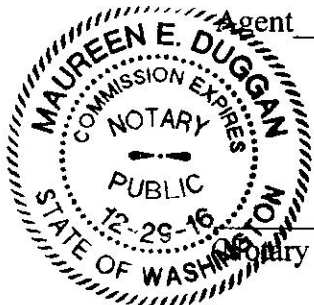

METROPOLITAN KING COUNTY COUNCIL NOTICE OF ENACTMENT ORDINANCE 17941

NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing in the King County Council Chambers, 10th Floor, King County Courthouse, Seattle, Washington on Monday November 10, 2014 at 11:00 A.M. The purpose of this hearing was to consider adoption of Proposed Substitute Ordinance No. 2014-0394, (Ordinance 17941) adopting the 2015-2016 Biennial Budget and making appropriations for the operation of county agencies and departments and capital improvements for the fiscal year beginning January 1, 2015 and ending December 31, 2016.

SUMMARY

The 2015-2019 capital program budget calls for capital outlays of about \$2.8 billion over the next six years. Of that budget authority, approximately \$1.1 billion is assumed for expenditure in the 2015-2016 biennium, including \$242 million for the Wastewater Treatment capital program, \$480 million for the Transit capital program, and \$16.5 million for building maintenance and repair.
