

SEPA ENVIRONMENTAL CHECKLIST

Purpose of checklist:

The proposed ordinance deals with agricultural policy, definitions and new permitted uses, as well as establishing a review board for variances and exceptions. It would impact prime farmlands because it adds Agricultural Activities and Agricultural Support Services to the definitions and list of permitted uses. It would also establish the Agricultural Technical Review Committee (ATRC) to address various issues and it would repeal KCC Chapter 20.54., the section on previous agricultural policy. It would not impact environmentally sensitive areas or the other issues listed.

Proposed measures to protect such resources or to avoid or reduce impacts are:

The purpose of the ordinance is to better protect prime farmlands and the uses that are permitted on them.
