1 A MOTION authorizing the manager of treasury operations
2 of King County to cancel the attached list of uncollectible
3 personal property taxes in the amount of \$664,752.04 for
4 the years 2009 through 2016.

5 WHEREAS, the duly appointed manager of treasury operations of King County,
6 Washington has made an affidavit pursuant to the terms of RCW 84.56.240 and
7 84.56.260 to the King County council relating the manager's diligent search and inquiry
8 for goods and chattels of the persons appearing on the list of delinquent taxpayers and the
9 manager's inability to find any such property from which the taxes could be collected,
10 and

11 WHEREAS, the duly appointed manager of treasury operations of King County,
12 Washington, has requested that the King County council cancel the taxes consistent with
13 RCW 84.56.240;

14 NOW, THEREFORE, BE IT MOVED by the Council of King County:

15 The taxes in the amount of \$664,752.04, as indicated in Attachments A, B and C
16 to this motion, from the records of treasury operations for the years 2009 through 2016,
17 shall be cancelled, but the obligation to King County is not forgiven. The manager of

18 treasury operations of King County is hereby authorized to cancel the taxes on the tax
19 rolls.

County Council on 2/5/2018, by the following vote:


