3           WHEREAS, the 2011 organization of the council was adopted via Motion 13411  
4 on January 31, 2011, and

5           WHEREAS, Motion 13411 established the committees of the council and  
6 outlined committee responsibilities, and

7           WHEREAS, Motion 13411 established the government accountability and  
8 oversight committee as the body responsible to consider and make recommendations on:  
9 policies relating to the department of assessments; elections; records and licensing;  
10 animal control; cable communications; the county fair; King County international airport;  
11 risk management; executive services such as telecommunications, facilities management,  
12 purchasing and real property management; capital project oversight; and wastewater  
13 treatment as well as strategic planning; performance management and performance  
14 measurement; management organizational structure; technology management; customer  
15 service; and the efficiency, cost effectiveness and performance of all branches of county  
16 government (legislative, executive and judicial), and

17           WHEREAS, Motion 13411 established the government accountability and  
18 oversight committee as the body responsible to make recommendations on the county's  
19 annual audit program and review the reports of the county auditor, and

20           WHEREAS, Motion 13411 further established the government accountability and  
21 oversight committee as the body responsible to track state and federal legislative action  
22 and develop recommendations on policy direction for the 2012 annual budget in the areas  
23 within the committee's purview, and

24           WHEREAS, the government accountability and oversight committee work  
25 program has been thoroughly discussed and developed by the committee and is attached  
26 to this motion;

27           NOW, THEREFORE, BE IT MOVED by the Council of King County:
