1 A MOTION confirming the Suburban Cities Association's
2 nominees for membership on the King County Flood
3 Control Zone District advisory committee.

5 WHEREAS, the 2006 King County Flood Hazard Management Plan identifies
6 approximately three hundred thirty-five million dollars in critical flood protection
7 programs and projects over ten years, not including projects to repair approximately
8 thirty-three million dollars in new damage from the floods in late 2006, and

9 WHEREAS, the council adopted Ordinance 15728 to form a countywide flood
10 control zone district to address these flood protection needs, and

11 WHEREAS, Ordinance 15728 also created a fifteen-person advisory committee
12 for the district in accordance with RCW 86.15.070, and

13 WHEREAS, Ordinance 15728 provides for the Suburban Cities Association to
14 nominate four members to the advisory committee for two-year seats, subject to
15 confirmation by the council, and

16 WHEREAS, in approving the nominations to the temporary seats, the King County
17 council stated their intent to alternate the membership of the seats allocated to the Suburban

18 Cities Association amongst cities within King County that do not have permanent seats, in
19 accordance with four general groupings of such cities as follows:

20 A. North county jurisdictions: Bothell, Duvall, Kenmore, Lake Forest Park,
21 Shoreline, Skykomish and Woodinville;p

22 B. Central county jurisdictions: Beaux Arts, Clyde Hill, Hunts Point, Issaquah,
23 Kirkland, Medina, Mercer Island, Newcastle, Redmond, Sammamish and Yarrow Point;

24 C. South county jurisdictions: Algona, Burien, Des Moines, Federal Way, Milton,
25 Normandy Park, Pacific and SeaTac; and

26 D. East county jurisdictions: Covington, Black Diamond, Enumclaw and Maple
27 Valley, and

28 WHEREAS, the Suburban Cities Association completed their nomination process
29 on May 9, 2007, and forwarded the names of persons representing cities in a manner
30 consistent with the above-stated council intent for geographic equity, and

31 WHEREAS, Ordinance 15728 directs the advisory committee to review and
32 recommend an annual work program and budget for the district, including capital
33 improvement program projects and funding levels and to submit recommendations to the
34 clerk of the King County council by August 31 of each year, and

35 WHEREAS, the first advisory committee meeting has been scheduled for May
36 17, 2007 to give the advisory committee sufficient time to complete its work by August
37 31, 2007;

38 NOW, THEREFORE, BE IT MOVED by the Council of King County:

41 two-year terms, to expire on May 16, 2009, is hereby confirmed:


- 42 A. The Honorable Ron Hansen, council member, city of Shoreline;


Motion 12523 was introduced on 5/21/2007 and passed by the Metropolitan King County Council on 5/29/2007, by the following vote:
