7 WHEREAS, King County's mission for the health of the public is to identify and
8 promote the conditions under which all people can live within healthy communities and
9 can achieve optimum health, as adopted in Motion 12475, and

10 WHEREAS, it is the intent of the county to improve the health of children, and

11 WHEREAS, significant disparities in children's health by race, ethnicity, region,
12 and income persist in King County and in some cases are growing, and

13 WHEREAS, research shows that effective policy for ensuring healthy children,
14 resulting in healthy, productive adults, rests on removing barriers that prevent children
15 from achieving consistent access to comprehensive health care, and

16 WHEREAS, the King County Children's Health Initiative ("CHI") was adopted
17 unanimously by the King County council in Motion 12507 on May 7, 2007, and includes

18 vision and mission statements for the CHI, goals, and three program components
19 including advocacy for insurance coverage for children, outreach to children and health
20 innovation pilot projects, and

21 WHEREAS, these organizations making contributions support the CHI, which
22 aims to improve the health of low-income children in King County, and

23 WHEREAS, these organizations support the vision of the CHI, which combines
24 targeted outreach and linkage strategies connecting families to comprehensive preventive
25 services including oral and mental health and a medical home, and

26 WHEREAS, the CHI vision rests on a public/private collaboration and a blend of
27 public/private funds to turn the vision into reality, and

28 WHEREAS, these organizations have specified that funds be earmarked for
29 implementation of innovative pilot approaches to improve children's health in King
30 County that will dovetail with the state's timeline including, but not limited to, such
31 things as best practices in outreach and linkage, oral health quality improvement and
32 integration, mental health integration pilot programs and on-line enrollment, and

33 WHEREAS these organizations have highlighted the children's health needs the
34 CHI addresses and encourage additional funders to contribute to the CHI, and

35 WHEREAS, these goals match the stated intent of the county in its adopted
36 Motion 12507 to dedicate one million dollars annually from the county general fund in
37 2007, 2008 and 2009 for the outreach component of the CHI and to partner with private
38 sector donors on creating pilot projects that will strengthen linkages in the health care
39 system and reduce barriers children face in accessing comprehensive health care;

40 NOW, THEREFORE, BE IT MOVED by the Council of King County:

41 The King County council authorizes the executive to accept donations that have
42 been or will be made, in accordance with the agreements and letters attached, Attachment
43 A to this motion, and in accordance with the policies established in Motion 12507, from
44 the following organizations and totaling in the following amounts: one million dollars
45 from Group Health Cooperative, two hundred thousand dollars from Children's Hospital
46 and Regional Medical Center, one hundred thousand dollars from Community Health
47 Plan, one hundred thousand dollars from Molina Healthcare of Washington, fifty
48 thousand dollars from Harborview Medical Center, fifty thousand dollars from University
49 of Washington Medical Center, fifty thousand dollars from Swedish Medical Center, fifty
50 thousand dollars from Evergreen Medical Center, forty thousand dollars from Northwest
51 Hospital, fifty thousand dollars from Valley Medical Center, twenty thousand dollars
52 from Washington State Hospital Association, thirty-three thousand dollars from Virginia
53 Mason Medical Center, sixty-one thousand dollars from the Robert Wood Johnson
54 Foundation, forty thousand dollars from United Way of King County, five thousand
55 dollars from First Choice Health, one thousand five hundred dollars from OneHealthPort
56 and one thousand dollars from Providence Health & Services for planning and
57 implementation support of the health innovation pilot projects for King County's
58 Children's Health Initiative.

59 The King County council recognizes Washington Dental Service for its
60 commitment to provide services valued at one million dollars in support of the Children's
61 Health Initiative and the W.K. Kellogg Foundation's grant of one hundred forty-eight



**Group Health Cooperative million dollar partnership fund for
children's health coverage expansion in King County**

King County's Children's Health Access Task Force has developed an innovative and realistic strategy for universal coverage for low income children in King County. Group Health would like to partner with the County to turn the vision into reality, building off the additional advances made at the state level via SB 5093, the children's health legislation. Our shared objectives are to:

- Foster and support innovative outreach programs to assure eligible low income children are enrolled in effective health coverage programs;
- Implement this locally based model, designed to improve health outcomes for King County low income children by providing effective, coordinated health care, including preventive oral health with demonstrably high levels of quality and patient satisfaction;
- Encourage efforts to improve and streamline enrollment and administration to maximize resources,
- Identify and leverage private and public funding and partnership opportunities for a sustainable coverage expansion; and
- Help assure all children in Washington have quality, effective health care coverage by modeling new innovative pilot approaches to improve children's health in King County that will dovetail with the State's timeline, including but not limited to such things as best practices in outreach and linkage, oral health quality improvement and integration, mental health integration pilot programs, on-line enrollment and financial sponsorship.

All funds provided by Group Health Cooperative or the Group Health Foundation will be earmarked for planning or implementation support. The funds may be used to build or strengthen public/private partnership support, prepare financial, or operating plans and for needs associated with launching King County's Children's Health Initiative as outlined in King County Motion 12507...

Group Health's million dollar cash contribution will be structured and disbursed as follows:

\$400,000 upon:

(1) King County Council's approval of at least \$1.0 million in dedicated county funding in 2007 for outreach and access activities as outlined in King County Motion 12507, Group Health's \$400,000 contribution is to be used for designing, planning and implementing innovative pilot projects in 2007, consistent with the terms stated above;

(2) King County's indication of its good faith intention to commit at least \$1 million per year in 2007, 2008 and 2009 (\$3 million total over three years) in dedicated county funding towards implementation of the Children's Health Initiative, as reflected in the King County projected budgets for 2007-09.

(3) King County Executive Ron Sims' commitment to actively seek an additional \$2.0 million in partnership funding to meet the goals outlined above and to secure adequate community funding for the innovative pilot projects no later than September 30, 2007.


\$600,000 Group Health community challenge fund. Group Health will provide leadership level support for a partnership by establishing an additional \$600,000 Group Health community challenge fund. Group Health will raise its total contribution to \$1.0 million dollars (the original \$400,000, plus the \$600,000 community challenge fund) provided that in addition to meeting the terms outlined above:

(1) King County secures additional contribution commitments totaling not less than \$2.0 million from other public or private community partners on or before September 30, 2007; and

(2) King County makes a firm commitment to continued outreach and full implementation of the Children's Health Initiative including program evaluation as outlined in King County Motion 12507. Oversight of the innovative pilot projects will be provided by the Health Innovation Implementation Committee with a workplan for this committee to be created by September 2007 or not later than four months after securing the additional \$2.0 million contribution commitments from other public or private community partners.

If conditions are not met on or before September 30, 2007 as outlined above, Group Health reserves the right to redirect the earmarked \$600,000 to the Group Health Foundation children's coverage/access expansion grant fund available to fund other projects in the GHC service area. King County may submit a subsequent application for a grant from this competitive grant fund in the event of such a redirection.

All funds will be transferred directly to a designated fund for King County's Children's Health Initiative. The first installment of \$400,000 will be sent within 60 days of formalization of this agreement, and the balance of \$600,000 will be sent within 45 days of securing the \$2 million in additional contribution commitments, provided the other terms of this grant offer have been met.

Washington Dental Service's Proposed Collaborative Pilot Program with King County

Purpose: To facilitate the expansion of oral health coverage for underserved children in King County.

King County's Children's Health Access Task Force (the "Task Force") has developed a Children's Health Initiative (or "CHI") that includes innovative and realistic strategies for achieving universal health care coverage for low income children in King County. An integral part of the CHI strategy is the provision of dental services to improve the oral health of low income children in King County. Washington Dental Service, in keeping with its mission, would like to partner with King County to help make this strategy a reality.

Oral health objectives shared between Washington Dental Service and King County are to:

- Foster and support innovative outreach programs to assure eligible low income children are enrolled in effective oral health coverage programs;
- Implement an effective and efficient delivery model designed to improve oral health outcomes for low income children by providing effective, coordinated oral health care, including oral health prevention, with demonstrably high levels of quality and patient satisfaction;
- Develop an improved, streamlined enrollment process with reduced administrative burden to maximize resources;
- Act as a model for other private and public funding and partnership opportunities for sustainable health care coverage expansion; and
- Demonstrate the effectiveness of this new model at a County level, and as a model under which children in Washington can be assured access to quality, effective oral health care.

In light of recent developments in the State Children's Health Care Act (the "Act"), the number of low income children in King County covered for dental services is expected to increase. Under the Act as signed by Governor Gregoire in March 2007, the upper end of the eligibility range for coverage is raised to 250% of the federal poverty level in July 2007, and to 300% of the federal poverty level in January 2009, allowing for families above 300% FPL to buy in at full cost. The recommendation of the Task Force was to cover children up to 300% of the federal poverty level, which is of continuing importance since the new Act will leave an 18-month period during which many low income children in King County will not yet be eligible for dental coverage.


Washington Dental Service proposes to respond to the recommendations of the Task Force given the new State context by providing, in a collaborative pilot program with King County, \$1 million of "in-kind" services and coverage relating to provision of dental services to children in King County who are between 250% and 300% of the federal poverty level and development of a buy-in plan for families above 300% FPL who would be able to purchase this coverage at full cost. This pilot program and in-kind

contribution would help provide an effective demonstration of the program between now and 2009. The Washington Dental Service contribution to the pilot program will include, but not be limited to, the development of a dental coverage program, establishing a broad network for access to care, and reimbursement for services provided. Washington Dental Service will work with the King County Health Innovation Implementation Committee (the "Committee") to identify and enroll eligible children into this pilot low income dental program.

Washington Dental Service's commitment to contribute \$1 million of in-kind services and coverage as outlined above will be subject to satisfaction of the following conditions no later than September 30, 2007:


1. King County Council's approval of \$1.0 million in dedicated county funding in 2007 for the outreach and access component of the Children's Health Initiative, and of its good faith intention to commit at least an additional \$1.0 million per year in 2008 and 2009 (\$3.0 million total over three years) in dedicated county funding for continued outreach and full implementation of the Children's Health Initiative, including program evaluation, as outlined in King County Motion 12507.
2. King County's securing of additional contribution commitments totaling not less than \$2.0 million from other public or private community partners, to fund innovative pilot projects under the oversight of the Committee, including but not limited to pilot approaches to best practices in outreach and linkage, oral health quality improvement and integration, mental health integration, on-line enrollment and financial sponsorship. We understand that the work plan for the other innovative pilot projects that will be overseen by the Committee will be created and finalized no later than September 2007.

This document represents Washington Dental Service's good faith statement of its intentions, but is not meant to create any legally binding obligations, which will arise only upon signing of definitive documentation between the parties.

Community Health Plan (CHP) wishes to thank you for your outstanding leadership and commitment to getting more children health insurance through the King County Children's Health Initiative.

CHP is interested in supporting the Children's Health Initiative given our mission and commitment to children in our communities. Our organization already contributes heavily to the goals of your initiative in the following manner:


- CHP covers thousands of people each month in King County - over 12,000 Basic Health patients and about 27,000 Medicaid patients enrolled in CHP in King County (recent data).
- Six Community Health Centers (CHCs) in King County served 145,000 patients in 2005.
 - 81,000 (56%) were insured.
 - 64,000 (46%) were uninsured. This is a higher percentage of uninsured for King County CHCs than the system faces as a whole - overall, 35% of the state CHCs patients are uninsured.
 - In 2005 our CHC network served **about 75% of the uninsured children in King County**. That means we provided medical or dental care to about 11,000 of the County's 15,000 uninsured children.

Along with our already extensive support and resources dedicated to ensuring that children have access to necessary health care services, CHP and our Board wishes to support the King County Children's Health Initiative by contributing \$100,000 over two years; \$50,000 in 2007 and \$50,000 in 2008, to further the goals of the initiative. If the scope of the Initiative changes due to new legislation at the State level that address the same need, CHP wishes to be consulted prior to funds being expended.

Our Board also advised that several key contingencies for CHP's contribution include the need to be assured the initiative is sustainable over a long period of time and that other entities are requested to contribute in a manner that supports the initiative being expanded throughout the State.

Again, thank you for your leadership, and we look forward to working closely with you to further the goals of the King County Children's Health Initiative.






