The purpose of this public hearing was to consider adoption of Proposed Ordinance 2022-0155 (Ordinance 19445) an ordinance relating to the County's procedures for adopting the 2024 Comprehensive Plan update. The Council then adopted this Ordinance at the same meeting.

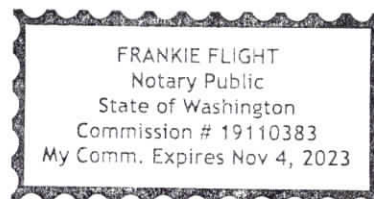
