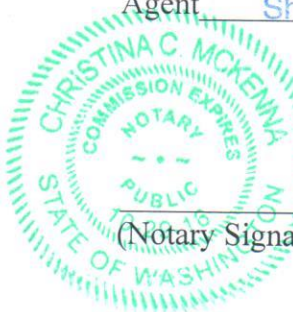

Proposed Ordinance 2015-0449

NOTICE IS HEREBY GIVEN, that a public hearing will be held before the Metropolitan King County Council, Room 1001, King County Courthouse, Seattle, Washington, on the 14th day of March, 2016, at 1:30 p.m., to consider adoption of Proposed Ordinance 2015-0449, prohibiting use of an electronic smoking device while on or in a transit vehicle or while in or at a bus shelter or transit property or properties; adding new provisions to K.C.C. section 28.95.010 and prescribing penalties. The Proposed Ordinance is proposed under the authority granted to the county legislative authorities under RCW 36.32.120 (7), to make and enforce appropriate resolutions and ordinances including all police and sanitary regulations not in conflict with state law.

### SUMMARY

This Proposed Ordinance would add the use of electronic smoking devices to prohibited activities in, on or in relation to transit properties and structures as defined by KCC 28.92.030 and 28.92.170. The ordinance amends KCC 28.96.010, B that identifies prohibited conduct not amounting to a violation of another applicable state or local criminal law bearing a greater penalty than is provided under the chapter. If adopted, a person using electronic smoking device in violation of K.C.C. 28.96.010 B.1, would be guilty of a misdemeanor.
