NOTICE IS HEREBY GIVEN, that a public hearing will be held before the Metropolitan King County Council on the 5th day of September, 2023, at 1:00 p.m., to consider adoption of Proposed Ordinance 2023-0249, which will enable the county to transfer real property interests related to the Puget Sound Emergency Radio Network as part of an intergovernmental transfer agreement without financial compensation. The public hearing will be held at the King County Courthouse, 516 3rd Avenue, Room 1001, Seattle, Washington. Information on this public hearing, including how to submit public testimony and how to attend the meeting, will be posted on the Council's website ahead of the hearing.

STATE OF WASHINGTON, COUNTIES OF KING AND SNOHOMISH

This ordinance would authorize the transfer of King County's interest in the assets and liabilities that comprise the Puget Sound Emergency Radio Network System, pursuant to the terms of the Puget Sound Emergency Radio Network Transfer Agreement, including, but not limited to, real and personal property interests and certain facilities, improvements, agreements, funding, documents, equipment, permits, licenses, and other related assets and liabilities.
