AMENDMENTS DETAIL

The following amendments are included to further clarify the ordinances to implement the new Regional Animal Services model.

Proposed Ordinance 2010-0325

The proposed amendments would:

1. Tier 2: Adds a new Tier 2 fund to account for Regional Animal Services revenues and expenditures.
2. Executive Request: Eliminates the charge for private animal placement permits and eliminate a duplicate reference and clarifies reporting requirements for veterinarians and shelters when transferring animal ownership so that contact information will be provided as available and would include additional information about the animal.
3. Livestock: Differentiates livestock impound/redemption fees for large and small livestock (as defined by Title 21). Small livestock fees would be \$45, large livestock fees would be \$100 or actual cost, whichever is greater.
4. Deceased Animal Pick-Up: Would increase the unlicensed deceased animal pick-up fee to \$50, instead of the proposed \$75.
5. Emergency Housing: Adds a provision that would allow for increases in the maximum allowable animals at hobby kennels and catteries in the event of an Executive declared emergency.
6. Reporting Requirements: Adds a provision for biannual program reporting to the council to align with the reporting requirements for cities contracting for Regional Animal Services (per Proposed Ordinance 2010-0326) and adds reporting requirements related to finances of the regional animal services program and average length of stay.
7. PAO Recommendation: Corrects a typographical error and retains Chapter 11.04 authority for boarding the number of dogs or cats allowed by kennel and cattery licenses.
8. PAO Recommendation on Solicitation of Donations: Would allow the director of the department of executive services, the manager of the records and licensing services division, the manager of the regional animal services section, and staff who report directly to those officers or officials to solicit charitable donations and bequests in support of the regional animal services program. The Councilmembers and their staff who report directly to them to solicit charitable donations and bequests in support of the regional program. The current language only authorizes the Executive to solicit charitable donations and bequests for the program.

Title amendments are also prepared to align with the amendments above (*see crosswalk*).

Proposed Ordinance 2010-0327

1. OMB proviso: Places a proviso in the Office of Management and Budget appropriation unit directing the Executive to include a Regional Animal Services appropriation unit and general fund transfer to the new fund created in PO 2010-0325.
2. Canvassing: Canvassing in the unincorporated area may not start before 1:00 p.m. on Sunday. *(No title amendment is needed.)*
3. **Title amendment T1** is needed if amendment 1 is passed.
