STRIKING AMENDMENT TO PROPOSED ORDINANCE 2015-0278, VERSION

1

On page 1, beginning on line 7, strike everything through page 4, line 55, and insert:

"STATEMENT OF FACTS:

1. Chapter 87.03 RCW authorizes the formation of an irrigation district for the purpose of irrigation of land.

2. RCW 87.03.019 allows irrigation districts to participate in and expend revenue on cooperative watershed management actions, for the purposes of water supply, water quality and water resource and habitat protection and management.

3. To initiate the formation of an irrigation district, a petition signed by the requisite number of property owners and containing the information required by RCW 87.03.020 shall be presented to the county legislative authority, together with a bond in a sum double the amount of the probable cost of organizing the proposed district.

4. On June 30, 2015, a petition, accompanied by a cash bond, was filed with the King County council requesting that necessary steps be taken to

18 organize an irrigation district in King County to be known as the
19 Snoqualmie Valley watershed improvement district.

20 5. Subsequent to filing the petition, petitioners requested the council
21 correct the petition by modifying the legal description and adding
22 additional nominations for initial board members, and petitioners provided
23 the council a list of parcels to be included within the boundaries of the
24 district, including acreage, tax parcel number, an address and an owner's
25 name. Included on that list are parcels owned by King County. The
26 corrected petition is Attachment A to this ordinance.

27 6. In accordance with the terms of the petition, property owned by
28 governmental entities and parcels of less than two acres are to be excluded
29 from the proposed district and therefore owners of such properties shall
30 not be eligible to vote in the election of whether an irrigation district shall
31 be formed and for the election of the directors.

32 7. The parcel list provided by the petitioners was updated with current
33 information, including taxpayer name and address and parcel size
34 provided by the department of assessments. The parcel list was also
35 modified to remove government-owned parcels and parcels less than two
36 acres in size. The updated parcel list is Attachment B to this ordinance.

37 8. Subsequent to filing the corrected petition, one person requested in
38 writing to be removed from the nominations for initial board members.

39 9. The petitioners complied with RCW 87.03.001 and chapter 36.93 RCW
40 and the petitioners filed a notice of intention to the boundary review board

41 on August 4, 2015. As part of the review by the boundary review board,
42 the petitioners filed an updated legal description for the boundaries of the
43 proposed district. The updated legal description is Attachment C to this
44 ordinance. The proposed action of creating the irrigation district was
45 deemed approved by the boundary review board on September 17, 2015.

46 10. Once the district is created, the processes in chapter RCW 87.03 shall
47 apply to any petition to add or exclude parcels from the district.

48 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

49 SECTION 1. The corrected petition requesting organization of the Snoqualmie
50 Valley watershed improvement district, Attachment A to this ordinance, is hereby
51 accepted as presented.

52 SECTION 2. A cash bond, in a sum double the amount of the probable cost of
53 organizing the proposed irrigation district, is hereby accepted as sufficient.

54 SECTION 3. The proposed irrigation district shall be known as the Snoqualmie
55 Valley watershed improvement district.

56 SECTION 4. The boundaries of the proposed district shall be as set forth in
57 Attachment C to this ordinance.

58 SECTION 5. The ballot shall reflect the nominees for the initial board members
59 as shown in Attachment A to this ordinance, except that Steven Van Ess shall not be
60 included as a nominee.

61 SECTION 6. The parcel list, Attachment B to this ordinance, shall be used by the
62 clerk of the council as the list of eligible voters owning qualifying property under the

63 petition for the election of whether an irrigation district shall be formed and for the
64 election of the directors.

65 SECTION 7. The election shall be carried out in the manner detailed in
66 Attachment D to this ordinance and in accordance with chapter 87.03 RCW. The election
67 date of November 24, 2015, is hereby set."

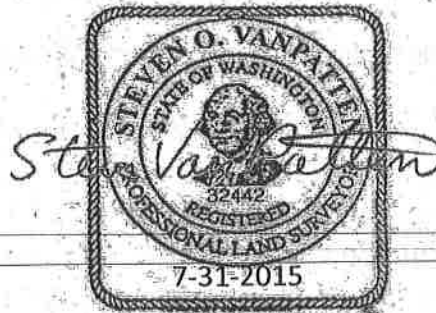

THE ELECTION PROCESS

THE ELECTION

The King County Council is responsible for conducting the district's formation election. Pursuant to RCW 87.03.032, the Council elects to use vote by mail to conduct the district formation election and election of directors. An election day of November 24, 2015, has been selected and ballots must be delivered to the Clerk of the Council or mailed with a postmark by that date and received by the Clerk by November 30, 2015 to be counted toward the election.

THE BALLOT

The County will prepare the ballots, ballot envelopes, and instructions indicating how joint ownership and community property votes are cast as well as a request to forward the ballot to the property owner if different from addressee. Voting rights shall be allocated as follows: two votes for each five acres of assessable land or fraction thereof. The chart below provides examples of how many votes parcels of differing acreage are entitled to receive. Additionally, electors (property owners) may receive more than one ballot if they own multiple parcels within the proposed district.

Ballots will be coded to indicate how many votes each ballot is worth.

The ballot shall contain the following language:

"Irrigation District – YES"

"Irrigation District – NO"

The names of the persons to be voted for as directors of the district.

To be counted in this election, ballots must conform to these requirements and the voting instructions will advise the electors of the importance of the following requirements:

1. Voted ballots must be sealed and placed in a ballot envelope (provided) and the ballot envelope must be sealed in a return certification envelope (provided). The certification envelope will contain a "voters certificate" and a "witness certification" on the back of the envelope as follows:

Voters Certification

I certify as true, under penalty of perjury under the laws of the State of Washington, that I am a landowner within the proposed district who is 18 years or more of age, a citizen of the United States, a resident of the State of Washington, and hold title or evidence of title to assessable land in the proposed district. If the landowner is a corporation, I certify as true, under penalty of perjury under the laws of the State of Washington, that I am a duly authorized agent for the purpose of voting on this election by the corporation.

2. Both the "voter's certification" and the "witness certification" must be completed and signed as indicated. Unsigned or unwitnessed ballots will not be counted.

3. Ballots must be hand delivered to the King County Clerk's Office prior to 4:30 p.m. on November 24, 2015; or mailed to the Clerk, postmarked no later than midnight on November 24, 2015, and received by the Clerk by 4:30 p.m. on November 30, 2015.

Ballots will be kept unopened and secure under the responsibility of the Clerk until the time in which ballots may be received is closed. The Council appoints the Clerk and assigned staff to proceed at once to determine whether the voters submitting ballots are qualified to vote and to count and tally the votes of those determined to be qualified.

The King County Council will meet on December 7, 2015, to canvass the returns. If it appears that at least two-thirds of all votes cast are in favor of the district, the Council shall by ordinance declare the district duly organized and shall declare the qualified persons receiving the highest number of votes to be duly elected directors and shall cause a certified copy of the ordinance to be filed for record in the offices of the Elections Director and the Assessor.
