1 AN ORDINANCE approving and adopting the collective  
2 bargaining agreement negotiated by and between King  
3 County and International Brotherhood of Teamsters Local  
4 117 (Professional & Technical and Administrative  
5 Employees) representing employees in the departments of  
6 adult and juvenile detention, development and  
7 environmental services, executive services, natural  
8 resources and parks, public health, transportation, and the  
9 office of information resources management; and  
10 establishing the effective date of said agreement.

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. The collective bargaining agreement negotiated between King  
14 County and International Brotherhood of Teamsters Local 117 (Professional & Technical  
15 and Administrative Employees) representing employees in the departments of adult and  
16 juvenile detention, development and environmental services, executive services, natural  
17 resources and parks, public health, transportation, and the office of information resources

18 management, and attached hereto is hereby approved and adopted by this reference made  
19 a part hereof.

20 SECTION 2. Terms and conditions of said agreement shall be effective from  
21 January 1, 2009, through and including December 31, 2010.







1 **ARTICLE 2: UNION RECOGNITION AND MEMBERSHIP**

2       **Section 2.1 Recognition.** The County recognizes the Union as the exclusive collective  
3 bargaining representative of all employees whose job classifications are listed in the attached  
4 Addendum A and Addendum B made a part hereof by this reference.

5       **Section 2.2 Union Membership.** It shall be a condition of employment that all employees  
6 covered by this agreement who are members of the Union in good standing on the effective date of  
7 this agreement shall remain members in good standing and those who are not members on the  
8 effective date of this agreement shall, on the thirtieth day following the effective date of this  
9 agreement, become and remain members in good standing in the Union, or pay fees to the Union to  
10 the extent permitted by law. It shall also be a condition of employment that all employees covered by  
11 this agreement and hired or assigned into the bargaining unit on or after its effective date shall, on the  
12 thirtieth day following the beginning of such employment, become and remain members in good  
13 standing in the Union, or pay fees to the Union to the extent permitted by law.

14       Provided however, that nothing contained in this section shall require an employee to join said  
15 Union who can substantiate in accordance with case law bona fide religious tenets or teachings that  
16 prohibits the payment of dues or initiation fees to Union organizations. Such employee shall pay an  
17 amount of money equivalent to regular union dues and initiation fee; said amounts shall be paid to a  
18 non-religious charity mutually agreed upon by the employee affected and the Union to which such  
19 public employee would otherwise pay the dues and initiation fee. The public employee shall furnish  
20 proof to the Union each month that such payment has been made.

21       Employees outside of the bargaining unit may be temporarily assigned to work within the  
22 bargaining unit for a period not to exceed thirty (30) days.

23       **Section 2.3 Dues Deduction.** Upon receipt of written authorization individually signed by a  
24 bargaining unit employee, the County shall have deducted from the pay of such employee the amount  
25 of dues and initiation fee or the appropriate fair share payment for temporary employees, as certified  
26 by the Secretary-Treasurer of the Union, and shall transmit the same to the Secretary-Treasurer of the  
27 Union.

28       The Union will indemnify, defend and hold the County harmless against any claims made and

1 against any suit instituted against the County on account of any check-off of dues for the Union. The  
2 Union agrees to refund to the County any amounts paid to it in error on account of the check-off  
3 provision upon presentation of proper evidence thereof.

4 **Section 2.4 New Bargaining Unit Member Reporting.** The County will require all new  
5 employees hired, transferred, or promoted into a position included in the bargaining unit to complete  
6 a form to inform the Union of their hire. One copy of the form will be retained by County payroll,  
7 one copy of the form will be given to the employee and the original will be sent to the Union. The  
8 County will notify the Union of any employee leaving the bargaining unit.

9 **Section 2.5 Bargaining Unit Lists.** The County will transmit to the Union a current listing  
10 of all employees in the bargaining unit within thirty (30) days of the Union's request for such a list,  
11 not to exceed twice per calendar year. For all employees performing bargaining unit work, the list  
12 shall include the name of the employee, classification, home address, department and salary.

13 **Section 2.6 Union Security and Job Removal.** Failure by an employee to satisfy the  
14 requirements of Section 2 shall constitute cause for dismissal; provided that King County has no duty  
15 to act until the Union makes a written request for discharge and verifies that the employee received  
16 written notification of the delinquency including the amount owing, the method of calculation, and  
17 notification that non-payment after a period of no less than seven (7) days will result in discharge by  
18 the County. A copy of each written notification shall be mailed to the County concurrent with its  
19 mailing to the employee.

20 **Section 2.7 Payroll Deduction for Political Contributions – Democratic, Republican,**  
21 **Independent Voter Education (D.R.I.V.E.).** The Employer agrees to deduct voluntary  
22 contributions from the paycheck of all employees covered by the Agreement who individually elect to  
23 make contribution to D.R.I.V.E. D.R.I.V.E. shall notify the Employer of the amounts designated by  
24 each contributing employee that are to be deducted from his/her paycheck for all weeks worked. The  
25 phrase "weeks worked" excludes any week other than a week in which the employee earned a wage.  
26 The Employer shall transmit to D.R.I.V.E. National Headquarters on a monthly basis, in one check,  
27 the total amount deducted along with the name of each employee on whose behalf a deduction is  
28 made, and the amount deducted from the employee's paycheck.

1 **ARTICLE 3: RIGHTS OF MANAGEMENT**

2       **Section 3.1 Management Rights.** The Union recognizes the prerogatives of the County to  
3 operate and manage its affairs in all respects in accordance with its responsibilities and powers of  
4 authority, subject to the terms and conditions of this Agreement.

5       **Section 3.2 Specific Enumerated Rights.** The County shall have the right to discipline and  
6 discharge for just cause, the right to layoff employees for lack of work or funds; or for the occurrence  
7 of conditions beyond the control of the County; or when such continuation of work would be wasteful  
8 and unproductive. The County shall further have the right to hire, appoint, promote, train, assign and  
9 direct the workforce; develop and modify classification specifications, allocate positions to those  
10 classifications, determine reasonable schedules of work, schedule overtime work, and to establish the  
11 methods and processes by which work is performed, the right to establish reasonable rules; and the  
12 right to take whatever actions are necessary in emergencies in order to assure the proper functioning  
13 of the Department.

14       **Section 3.3** The County shall not contract out work which the members of the Union have  
15 historically performed unless it is required by law or is a business necessity due to an emergency  
16 situation or to augment the workforce on a short-term, temporary basis. Except for emergency  
17 situations, the County shall provide notice to the Union of its intent to contract out and, upon request,  
18 bargain the decision and/or effects of that decision. Except as provided herein, under no  
19 circumstance shall the County agree to any long-term or permanent contracting out of bargaining unit  
20 work. Nothing in this provision shall limit what the County has historically contracted out, and no  
21 jobs will be eliminated due to contracting out. Term limited temporary (“TLT”) employees will only  
22 be utilized to perform bodies of work in accordance with King County Code.

1 **ARTICLE 4: HOLIDAYS**

2 **Section 4.1 Recognized Holidays.** Employees covered by this Labor Agreement shall be  
3 eligible for holidays with pay as provided by King County Code 3.12.230. Should King County Code  
4 be revised, the Union shall be advised of such revision and if after bargaining regarding the revision,  
5 the Union wishes to adopt such revision, it shall become part of the Labor Agreement.

6 a) Regular, probationary, provisional and term-limited temporary employees shall be  
7 granted the following holidays with pay:

19 and any special or limited holidays as declared by the president or governor, and as approved by the  
20 Metropolitan King County Council.

21 **Section 4.2 Holidays on Scheduled Day Off.** For holidays falling on a Saturday, the Friday  
22 before shall be a paid holiday. For holidays falling on a Sunday, the Monday following shall be a  
23 paid holiday.

24 **Section 4.3 Personal Holidays.** Personal holidays shall be administered through the  
25 vacation plan. One (1) day shall be available for use on the first of October and one (1) on the first  
26 day of November each year.

27 **Section 4.4 Eligibility and Compensation Rules.** In addition to the aforementioned holiday  
28 benefits provided in King County Code 3.12.230, this Labor Agreement shall provide for the  
following:



1           **A. Holiday Pay Counts as Time Worked.** Holidays paid for but not worked shall be  
2 recognized as time worked for the purpose of determining weekly overtime.

3           **B. Eligibility for Holiday Pay.** An employee must be in a pay status, either the  
4 employee's scheduled work day before, or employee's scheduled working day after a holiday in order  
5 to receive holiday pay. An employee leaving County employment the day prior to the holiday shall  
6 not receive holiday pay.

7           **C. Compensation for Work on a Holiday.** Work performed by overtime eligible  
8 employees on holidays shall be paid at one and one-half (1-1/2) times the regular rate in addition to  
9 the regular holiday pay.

10           **D. Calculation of Holiday Pay.** Holiday pay shall be based on the number of hours  
11 in the employee's regular work week, up to a maximum of eight (8) hours for regular full-time  
12 employees with a forty (40) hour week, or seven (7) hours for regular full-time employees with a  
13 thirty-five (35) hour work week. Hourly employees on flex or alternative work schedules may be  
14 allowed to adjust their schedules during a holiday week so as to be eligible for holiday pay plus all  
15 non-holiday work hours for that work week. Part-time regular employees shall receive pro rated  
16 holiday pay based on their normal hours of work per week in relation to a full-time schedule of thirty-  
17 five (35) or forty (40) hours.

18           **E. Alternate/Flextime Work Schedules.** Hourly employees on alternative work  
19 schedules/flextime (working four days in five, or nine days in ten) who take holiday time off in excess  
20 of the seven (7) or eight (8) hours of holiday provided, and who do not adjust their work schedules as  
21 provided in D. above shall make up the difference using accrued vacation time, compensatory time,  
22 or leave without pay. If a holiday falls on an hourly employee's regular day off, due to an alternative  
23 or flex work schedule, the employee will be paid for the holiday as provided in Section 4.4.D above.  
24 In lieu of holiday pay, the employee may be granted paid time off equivalent to the holiday, to be  
25 scheduled by mutual agreement with the supervisor within the same pay period when the holiday  
26 occurs. The employee must request the paid time off at least two weeks prior to the holiday.

1 **ARTICLE 5: VACATIONS**

2 **Section 5.1 Vacation Accrual.** Employees covered by this Labor Agreement shall be  
3 eligible for vacations with pay as provided by King County Code 3.12.190. Should King County  
4 Code be revised, the Union shall be advised of such revision and if after bargaining regarding the  
5 revision, the Union wishes to adopt such revision, it shall become part of the Labor Agreement.

6 **A. Accrual Rate Schedule.** Regular, probationary, provisional and term-limited  
7 temporary employees shall accrue vacation leave for each hour in regular pay status exclusive of  
8 overtime as described in the following table:

26 **B. Commencement of Accrual.** Employees eligible for leave shall accrue vacation  
27 leave from their date of hire in a leave eligible position.

28 **C. Vacation Eligibility.** Employees eligible for leave shall not be eligible to take or

1 be paid for vacation leave until they have successfully completed their first six (6) months of County  
2 service in a leave eligible position, and if they leave County employment prior to successfully  
3 completing their first six (6) months of County service, shall forfeit and not be paid for accrued  
4 vacation leave. This section does not apply to employees who use accrued vacation leave for a  
5 qualifying event under the Washington Family Care Act.

6 **D. Vacation Payout at Separation.** Employees eligible for leave shall be paid for  
7 accrued vacation leave to their date of separation up to the maximum accrual amount if they have  
8 successfully completed their first six months of County service. Payment shall be the accrued  
9 vacation leave multiplied by the employee's regular rate of pay in effect upon the date of leaving  
10 County employment less mandatory withholdings.

11 **E. No Advance of Vacation Pay.** Employees eligible for leave shall not use or be  
12 paid for vacation leave until it has accrued and such use or payment is consistent with the provisions  
13 of this Article.

14 **F. No County Work During Vacation.** No employee eligible for leave shall work  
15 for compensation for the County in any capacity during the time that the employee is on vacation  
16 leave.

17 **G. Vacation Payout Upon Death.** In cases of separation from County employment  
18 by death of an employee with accrued vacation leave and who has successfully completed his/her first  
19 six (6) months of County service in a leave eligible position, payment of unused vacation leave up to  
20 the maximum accrual amount shall be made to the employee's estate, or, in applicable cases, as  
21 provided for by state law, RCW Title 11.

22 **H. Accrual Rate Upon Return After Separation.** If an employee resigns from a  
23 full-time regular or part-time regular position or is laid off and subsequently returns to County  
24 employment within two years from such resignation or layoff, as applicable, the employee's prior  
25 County service shall be counted in determining the vacation leave accrual rate under Section A.

26 **Section 5.2 Vacation Use.** In addition to the aforementioned vacation benefits provided in  
27 King County Code 3.12.190, this Labor Agreement shall provide for the following:

28 **A. Increments of Use.** Overtime eligible employees may use vacation leave in one-

1 quarter (1/4) hour increments, at the discretion of the manager.

2                   **B. Vacation Accrual Maximum and Carryover Rules.** Employees eligible for  
3 leave may accrue up to sixty (60) days (480 hours) of vacation. The maximum is 420 hours for 35  
4 hour per week employees. Leave eligible part time employees may accrue vacation leave pro rated to  
5 reflect their normally scheduled work week. Leave eligible employees shall continue to accrue  
6 vacation in excess of the maximum during the calendar year in which they reach the maximum;  
7 however they must use vacation leave beyond the maximum accrual amount on or before the last day  
8 of the pay period that includes December 31 of each year. The County will give notice on or about  
9 July 1 of each year to employees whose vacation accrual will exceed 480 hours (or 420 hours for 35  
10 hour per week employees) by the end of the year. Employees who leave King County employment  
11 for any reason will be paid for their unused vacation up to the maximum specified herein. Employees  
12 shall forfeit the excess accrual effective the last day of the pay period that includes December 31st of  
13 each year; unless the employee has received approval in accordance with County policies and  
14 procedures to carry over excess vacation accrual into the following year.

15                   **C. Vacation Scheduling.** The Manager shall be responsible for establishing a  
16 vacation schedule that maximizes employee vacation opportunities while achieving the efficient  
17 functioning of the unit. Employees are encouraged to submit vacation requests as far in advance as  
18 possible. Managers will respond at the earliest opportunity, but no more than ten working days after  
19 employee vacation requests.

20                   **D. Dispute Resolution Regarding Vacation Approval.** Business needs within  
21 divisions and work groups affect how management responds to employee vacation requests. Labor  
22 Management Committees are an appropriate forum for discussion of policies and procedures for  
23 vacation approval.

1 **ARTICLE 6: SICK LEAVE**

2 **Section 6.1 Sick Leave Ordinance.** Employees covered by this Labor Agreement shall be  
3 eligible for sick leave benefits as provided by King County Code 3.12.220. Should King County  
4 Code be revised, the Union shall be advised of such revision and if after bargaining regarding the  
5 revision, the Union wishes to adopt such revision, it shall become part of the Labor Agreement.

6 **Section 6.2 Sick Leave Accrual.** Regular, provisional, probationary and term-limited  
7 temporary employees shall accrue sick leave benefits at the rate of 0.04616 hours for each hour in  
8 regular pay status excluding overtime up to a maximum of eight (8) hours per month. Sick leave  
9 shall not begin to accrue until the first of the month following the month in which the employee  
10 commenced employment. The employee is not entitled to sick leave if not previously earned. If the  
11 County adopts a payroll system that allows sick leave accruals to begin the first day of employment,  
12 such change shall become effective immediately.

13 **Section 6.3 Vacation in Lieu of Sick Leave -** During the first six (6) months of service in a  
14 leave eligible position, employees eligible to accrue vacation leave may, at the manager's discretion,  
15 use any accrued days of vacation leave as an extension of sick leave. If an employee does not work a  
16 full six (6) months in a leave eligible position, any vacation leave used for sick leave must be  
17 reimbursed to the County upon termination. This section does not apply to an employee who uses  
18 accrued vacation leave for a qualifying event under the Washington Family Care Act.

19 **Section 6.4 Unlimited Accrual.** There shall be no limit to the hours of sick leave benefits  
20 accrued by an eligible employee.

21 **Section 6.5 Separation and Return From Separation.** Separation from or termination of  
22 County employment except by reason of retirement or layoff due to lack of work, funds, efficiency  
23 reasons or separation for non disciplinary medical reasons, shall cancel all sick leave accrued to the  
24 employee as of the date of separation or termination. Should the employee resign, be separated for  
25 non-disciplinary medical reasons or be laid off and return to County employment within two years,  
26 accrued sick leave shall be restored; provided, that such restoration shall not apply where the former  
27 employment was in a term-limited position.

28 **Section 6.6 Sick Leave Payout Upon Separation.** Employees eligible to accrue leave and

1 who have successfully completed at least five years of County service and who retire as a result of  
2 length of service or who terminate by reason of death shall be paid, or their estates paid for as  
3 provided for by RCW Title 11, as applicable, an amount equal to thirty-five percent (35%) of their  
4 unused, accumulated sick leave multiplied by the employee's rate of pay in effect upon the date of  
5 leaving County employment less mandatory withholdings.

6 **Section 6.7 Coordination With Workers' Compensation Benefits.** An employee must use  
7 all of his or her sick leave before taking unpaid leave for his or her own health reasons. If the injury  
8 is compensable under the County's workers compensation program, then the employee has the option  
9 to augment or not augment time loss payments with the use of accrued sick leave. For a leave for  
10 family reasons, the employee shall choose at the start of the leave whether the particular leave would  
11 be paid or unpaid; but when an employee chooses to take paid leave for family reasons, he or she may  
12 set aside a reserve of up to eighty (80) hours of accrued sick leave. An employee who has exhausted  
13 all of his or her sick leave may use accrued vacation leave before going on leave of absence without  
14 pay, if approved by his or her appointing authority.

15 **Section 6.8 Use of Sick Leave.** Accrued sick leave shall be used for the following reasons:

16 A. The employee's bona fide illness; provided, that an employee who suffers an  
17 occupational illness may not simultaneously collect sick leave and worker's compensation payments  
18 in a total amount greater than the net regular pay of the employee;

19 B. The employee's incapacitating injury, provided that:

20 An employee injured on the job may not simultaneously collect sick leave and worker's  
21 compensation payments in a total amount greater than the net regular pay of the employee; though an  
22 employee who chooses not to augment his or her worker's compensation time loss pay through the  
23 use of sick leave shall be deemed on unpaid leave status;

24 C. An employee who chooses to augment worker's compensation payments with the  
25 use of accrued sick leave shall notify the worker's compensation office in writing at the beginning of  
26 the leave;

27 D. Exposure to contagious diseases and resulting quarantine.

28 E. A female employee's temporary disability caused by or contributed to by

1 pregnancy and childbirth.

2 F. The employee's medical, ocular or dental appointments, provided that the  
3 employee's supervisor has approved the scheduling of sick leave for such appointments.

4 G. To care for the employee's child if the child has an illness or health condition  
5 which requires treatment or supervision from the employee;

6 H. An employee may not collect sick leave for physical incapacity due to any injury or  
7 occupational illness which is directly traceable to employment other than with the County.

8 I. To care for other family members, if:

9 1. the employee has been employed by the County for twelve months or more  
10 and has worked a minimum of one thousand forty hours (1040) in the preceding twelve (12) months  
11 for an employee on a forty (40) hour workweek, or nine hundred ten (910) hours for an employee on a  
12 thirty-five (35) hour workweek);

13 2. the family member is the employee's spouse or domestic partner, the  
14 employee's child, a child of the employee's spouse or domestic partner, the parent of the employee,  
15 employee's spouse or domestic partner or an individual who stands or stood in loco parentis to the  
16 employee, the employee's spouse or domestic partner, or the grandparent of the employee; and

17 3. the reason for the leave is one of the following:

18 a) the birth of a son or daughter and care of the newborn child, or  
19 placement with the employee of a son or daughter for adoption or foster care, if the leave is taken  
20 within twelve months of the birth, adoption or placement;

21 b) the care of the employee's child or child of the employee's spouse  
22 or domestic partner whose illness or health condition requires treatment or supervision by the  
23 employee; or

24 c) Care of a family member who suffers from a serious health  
25 condition.

26 **Section 6.9 Federal and State Law.** To the extent that a federal or Washington State law  
27 provides more extensive benefits for use of paid leave for family care, the Union and County agree  
28 that federal and/or state law shall prevail.

1           **Section 6.10 King County Family and Medical Leave.** An eligible employee may take a  
2 total of up to eighteen weeks unpaid leave for his or her own serious health condition, and for family  
3 reasons as provided in Sections 6.8.G and 6.8.I combined, within a twelve (12) month period. The  
4 twelve month period is counted as rolling backward from the date the employee goes on leave. To be  
5 eligible for leave to care for a family member, an employee must have been employed by the county  
6 for twelve months or more at any time, and worked a minimum of nine hundred ten (910) hours for  
7 an employee on a thirty-five (35) hour workweek, or one thousand forty (1040) hours for an employee  
8 on a forty (40) hour workweek in the preceding twelve months (paid leaves such as holiday, vacation  
9 and sick leave are not considered hours worked). The leave may be continuous, which is consecutive  
10 days or weeks, or intermittent, which is taken in whole or partial days as needed. Intermittent leave is  
11 subject to the following conditions:

12                   **A. Intermittent Leave for Birth/Adoption.** When leave is taken after the birth or  
13 placement of a child for adoption or foster care, an employee may take leave intermittently or on a  
14 reduced leave schedule only if authorized by the employee's appointing authority.

15                   **B. Intermittent Leave for Serious Health Condition.** An employee make take  
16 leave intermittently or on a reduced schedule when medically necessary due to a serious health  
17 condition of the employee or family member of the employee; and

18                   **C. Possible Transfer.** If an employee requests intermittent leave or leave on a  
19 reduced leave schedule under section B. above, that is foreseeable based on planned medical  
20 treatment, the appointing authority may require the employee to transfer temporarily to an available  
21 alternative position for which the employee is qualified and that has equivalent pay and benefits and  
22 that better accommodates recurring periods of leave than the regular position of the employee.

23           **Section 6.11 Coordination of Donated Leave.** Use of donated leave shall run concurrently  
24 with the eighteen work week family medical leave entitlement.

25           **Section 6.12 Continuation of Health Care Benefits.** The County shall continue its  
26 contribution toward health care during any unpaid leave taken under Section 6.10.

27           **Section 6.13 Return to Work.** An employee who returns from unpaid family or medical  
28 leave within the time provided in this Article is entitled, subject to bona fide layoff provisions, to:



1           A. the same position he or she held when the leave commenced; or

2           B. a position with equivalent status, benefits, pay and other terms and conditions of  
3 employment; and

4           C. the same seniority accrued before the date on which the leave commenced.

5           **Section 6.14 Failure to Return.** Failure to return to work by the expiration date of the leave  
6 of absence may be cause for removal and result in termination of the employee from County service.

7           **Section 6.15 Sick Leave Administration and Incremental Use.** In addition to the  
8 aforementioned sick leave benefits provided in King County Code 3.12.220, this Labor Agreement  
9 shall provide for the following:

10           A. Division management and employees are responsible for the proper administration  
11 of the sick leave benefit.

12           B. Overtime eligible employees may use sick leave in one-quarter (1/4) hour  
13 increments, at the discretion of the manager/designee.

14           **Section 6.16 Unused Sick Leave Conversion to Vacation.** Hourly employees who use  
15 sixteen (16) hours or less of sick leave in a payroll year (as reflected on the December 20th or last  
16 paycheck of the year) will be eligible to convert up to twenty-four (24) hours of sick leave to vacation  
17 hours. Employees must request such conversion no later than January 31 of the following year.

1 **ARTICLE 7: PAID LEAVES**

2 **Section 7.1 Paid Leave Ordinances.** Employees covered by this Labor Agreement shall be  
3 eligible for the following paid leave benefits as provided for in King County Code 3.12.210,  
4 3.12.215, 3.12.223, 3.12.225, 3.12.240, 3.12.260. Should King County Code be revised, the Union  
5 shall be advised of such revision and if after bargaining regarding the revision, the Union wishes to  
6 adopt such revision, it shall become part of this Labor Agreement.

7 **Section 7.2 Bereavement Leave (KCC 3.12.210).**

8 **A.** Employees eligible for paid leaves shall be entitled to three (3) working days of  
9 bereavement leave per occurrence, due to death of members of their immediate family. Employees  
10 shall be entitled to five (5) days of bereavement leave due to death of the employee's spouse or  
11 domestic partner, parent, or child.

12 **B.** Employees eligible for leaves who have exhausted their bereavement leave, shall  
13 be entitled to use sick leave in the amount of three (3) days for each instance of death when death  
14 occurs to a member of the employee's immediate family.

15 **C.** In cases of family death where no sick leave benefit exists, the employee may be  
16 granted leave without pay, or may be allowed to use accrued vacation, Executive Leave, and/or  
17 compensatory time.

18 **D.** In the application of any of the foregoing provisions, when a holiday or regular day  
19 off falls within the prescribed period of absence, it shall not be charged against the employee's sick  
20 leave account nor bereavement leave credit.

21 **E.** Immediate family means any of the following:

- 22 • Employee's spouse or domestic partner
- 23 • Parent of the employee, employee's spouse or domestic partner
- 24 • Grandparent of the employee, employee's spouse or domestic partner
- 25 • Child of the employee, employee's spouse or domestic partner
- 26 • Son-in-law or daughter-in-law of the employee, employee's spouse or
- 27 domestic partner
- 28 • Grandchild of the employee, employee's spouse or domestic partner

- Sibling of the employee, employee's spouse or domestic partner.

Also included is any person for whose financial or physical care the employee is principally responsible.

### **Section 7.3 Organ Donor Leave (KCC 3.12.215).**

1. The appointing authority shall allow employees eligible for family leave, sick leave, vacation leave or leave of absence without pay who are voluntarily participating as donors in life-giving or life-saving procedures such as, but not limited to, bone marrow transplants, kidney transplants, or blood transfusions to take five days paid leave without having such leave charged to family leave, sick leave, vacation leave or leave of absence without pay; provided that the employee shall:

a) Give the appointing authority reasonable advance notice of the need to take time off from work for the donation of bone marrow, a kidney, or other organs or tissue where there is a reasonable expectation that the employee's failure to donate may result in serious illness, injury, pain or the eventual death of the identified recipient.

b) Provide written proof from an accredited medical institution, organization or individual as to the need for the employee to donate bone marrow, a kidney, or other organs or tissue or to participate in any other medical procedure where the participation of the donor is unique or critical to a successful outcome.

2. Time off from work for the purposes set out above in excess of five (5) working days shall be subject to existing leave policies contracted in this Agreement.

### **Section 7.4 Donation of Leaves (KCC 3.12.223).**

1. **Vacation Leave Hours.** Vacation leave hours.

a) **Approval Required.** Any employee eligible for leave benefits may donate a portion of his or her accrued vacation leave to another employee eligible for leave benefits. Such donation will occur upon written request to and approval of the donating and receiving employees' department director(s), except that requests for vacation donation made for the purposes of supplementing the sick leave benefits of the receiving employee shall not be denied unless approval would result in a departmental hardship for the receiving department.

1                   **b) Limitations.** The number of hours donated shall not exceed the donor's  
2 accrued vacation credit as of the date of the request. No donation of vacation hours shall be permitted  
3 where it would cause the employee receiving the transfer to exceed his or her maximum vacation  
4 accrual.

5                   **c) Return of Unused Donations.** Donated vacation leave hours must be used  
6 within ninety calendar days following the date of donation. Donated hours not used within ninety  
7 days or due to the death of the receiving employee shall revert to the donor. Donated vacation leave  
8 hours shall be excluded from vacation leave payoff provisions contained in Article 5. For purposes of  
9 this section, the first hours used by an employee shall be accrued vacation leave hours.

10                   **2. Sick Leave Hours.**

11                   **a) Written Notice Required.** Any employee eligible for leave benefits may  
12 donate a portion of his or her accrued sick leave to another employee eligible for leave benefits upon  
13 written notice to the donating and receiving employees' department director(s).

14                   **b) Minimum Leave Balance Required (Donor).** No donation shall be  
15 permitted unless the donating employee's sick leave accrual balance immediately subsequent to the  
16 donation is one hundred hours or more. No employee may donate more than twenty-five hours of his  
17 or her accrued sick leave in a calendar year.

18                   **c) Return of Unused Donations.** Donated sick leave hours must be used  
19 within ninety calendar days. Donated hours not used within ninety days or due to the death of the  
20 receiving employee shall revert to the donor. Donated sick leave hours shall be excluded from the  
21 sick leave payoff provisions contained in Article 6, and sick leave restoration provisions contained in  
22 Article 6. For purposes of this section, the first hours used by an employee shall be accrued sick  
23 leave hours.

24                   **3. No Solicitation.** All donations of vacation and sick leave made under this section  
25 are strictly voluntary. Employees are prohibited from soliciting, offering or receiving monetary or  
26 any other compensation or benefits in exchange for donating vacation or sick leave hours.

27                   **4. Conversion Rate.** All vacation and sick leave hours donated shall be converted to  
28 a dollar value based on the donor's straight time hourly rate at the time of donation. Such dollar

1 value will then be divided by the receiving employee's hourly rate to determine the actual number of  
2 hours received. Unused donated vacation and sick leave shall be reconverted based on the donor's  
3 straight time hourly rate at the time of reconversion.

4 **Section 7.5 Leave for School Volunteer Service (KCC 3.12.225).** The division manager  
5 shall allow the use of up to three days of sick leave each year to allow employees to perform  
6 volunteer services at the school attended by the employee's child, the employee's grandchild, the  
7 child of the employee's domestic partner, or child that resides in the employee's home. Employees  
8 requesting to use sick leave for this purpose shall submit such request in writing specifying the name  
9 of the school and the nature of the volunteer services to be performed.

10 **Section 7.6 Jury Duty (KCC 3.12.240).** Any employee eligible for leave benefits who is  
11 ordered on a jury shall be entitled to his or her regular County pay; provided, that fees for such jury  
12 duty are deposited, exclusive of mileage, with the Finance Division of the Department of Executive  
13 Services. Employees shall report back to their work supervisor when dismissed from jury service.

14 **Section 7.7 Military Leave (KCC 3.12.260).** A leave of absence for active military duty or  
15 active military training duty shall be granted to eligible employees in accordance with applicable  
16 provisions of state and/or federal law; provided, that a request for such leave shall be submitted to the  
17 appointing authority in writing by the employee and accompanied by a validated copy of military  
18 orders ordering such active duty or active training duty. If an employee is called to involuntary active  
19 duty, she/he may be eligible for health benefit continuation and pay supplementation in accordance  
20 with County policy at the time the individual is called to active duty.

21 **Section 7.8 Unpaid Leaves of Absence.**

22 **A. Short-Term Leaves of Absence.** A leave of absence without pay for a period not  
23 exceeding thirty (30) consecutive days may be granted by the applicable Division Director.

24 **B. Long-Term Leaves of Absence.** The Director of the Human Resources Division  
25 of the Department of Executive Services may grant a request for a leave of absence for a period  
26 longer than thirty (30) days with the favorable recommendation of the applicable Department  
27 Director. Long-Term leaves may be conditional or unconditional, with any conditions set forth in  
28 writing at the time that the leave is approved.

1           **C. Reasonable Approval.** Leaves specified in A. and B. above shall not be unduly  
2 denied.

3           **D. Early Return.** An employee who is on a leave of absence without pay may return  
4 from the leave before its expiration date if the employee provides the appointing authority with a  
5 written request to that effect at least fifteen (15) days before the requested date of return.

6           **Section 7.9 Executive Leave.** Regular career service employees covered by this Agreement  
7 who are in positions that are exempt from the overtime provisions of the federal Fair Labor Standards  
8 Act may be granted up to ten (10) days of Executive Leave per calendar year in accordance with  
9 Executive Policy PER 8-1-1. Such employees will be entitled to up to five (5) days of paid Executive  
10 Leave per calendar year for the duration of this Agreement, under the following conditions:

11           **A.** Employees who are employed in an eligible bargaining unit position on January 1,  
12 2009, shall be allowed five (5) days of Executive Leave for use during 2009; those who are employed  
13 in a bargaining unit position after the effective date but before September 1, 2009 shall be allowed  
14 two days Executive Leave for use during 2009; those employed in an eligible bargaining unit position  
15 on or before June 1, 2010 shall be allowed five (5) days of Executive Leave for use during 2010;  
16 those who are employed in an eligible bargaining unit position after June 1, but before September 1,  
17 2010 shall be allowed two days Executive Leave for use during 2010.

18           **B.** There will be no cashout or carryover of unused Executive Leave to the following  
19 year.

20           **C.** Executive Leave will not be guaranteed to a probationary employee or to an  
21 employee whose most recent performance evaluation has an overall rating less than satisfactory, but  
22 may be granted at the discretion of management.

23           **D.** This section does not constitute a grant of Executive Leave after the expiration  
24 date of this Agreement.

25           **E.** Additional days of Executive Leave may be granted at the discretion of  
26 management pursuant to Executive Policy PER 8-1-1.

1 **ARTICLE 8. WAGE RATES**

2           **Section 8.1 Step Progression.** New employees shall be hired at Step 1 of their respective  
3 pay range or at a higher Step at management's discretion and advanced to the next Step after  
4 completion of a six (6) month period. Advancement to the next Step upon successful completion of  
5 an extended probationary period shall be made retroactive to the start of the seventh (7th) month of  
6 employment.

7           Employees will serve a probationary period as provided in Section 11.1 of the Personnel  
8 Guidelines. The probationary period will be at least six (6) months of service, but not more than  
9 twelve (12) months. If a probationary period is to be extended, written notice of the extension must  
10 be given to the employee before the employee completes the initial six-month probationary period.

11           **Section 8.2 Annual Step Increase.** Employees shall automatically advance to the next  
12 salary step annually on January 1, except for employees in their first six (6) months in a job  
13 classification, who shall advance from their entrance step to the step increment granted upon  
14 completion of their first six (6) months, and annually on January 1 thereafter.

15           Exception: Career service employees in the Department of Transportation Airport Division,  
16 the Department of Public Health, and the Department of Natural Resources and Parks shall receive  
17 step increases as provided in the King County Merit Pay Plan.

18           **Section 8.3 Work Out of Class/Acting Assignment.** In the event an employee is assigned,  
19 in writing, to perform duties of a higher classification for a period of one (1) work day or more,  
20 he/she shall be paid for all time so assigned at the first pay step of the higher classification or at the  
21 step which is the equivalent of two (2) steps (approximately five per cent-5%) more than the  
22 employee's previous salary step, whichever is greater, but not to exceed the top step of the new range.  
23 If the employee's former salary step includes an above-step-ten amount as a merit increase, the out-  
24 of-class pay shall be based on the above-step-ten amount as long as the employee qualifies for merit  
25 pay.

26           **Section 8.4. Request for Classification Review.** If there has been a gradual accretion or a  
27 significant change in an employee's duties and responsibilities over a period of twelve (12) months or  
28 longer, the employee or the division director may request a review of the classification by the Human

1 Resources Director. An employee is not eligible to submit a reclassification request if it has been less  
2 than twelve (12) months since the date of a previous classification determination for the position.  
3 The Position Description Questionnaire (PDQ) shall be submitted to the employee's departmental  
4 human resources manager for transmittal to the Human Resources Division of the Department of  
5 Executive Services (DES). The departmental human resources manager shall transmit the PDQ as  
6 soon as practical, but no more than sixty (60) calendar days after submission of the PDQ. Exception:  
7 An employee who is assigned and compensated to perform the duties of a position in a higher  
8 classification during a leave of absence of the regular incumbent in the position is not eligible to  
9 submit a request for a classification review.

10 **Section 8.4.A Reclassification date.** If HRD determines that an employee should be  
11 reclassified, the reclassification will be effective the first day of the next pay period after the date the  
12 HRD received the PDQ.

13 **Section 8.4.B Classification Appeals.** If the employee or division manager disagrees  
14 with the determination of HRD, the employee or manager may request a review by the HRD Director  
15 or designee.

16 **Section 8.4.C Classification Dispute Resolution.** If the Union disagrees with the  
17 classification decision of the HRD Director or designee, the Union may, within thirty (30) days of the  
18 date of the HRD Director/designee's decision, submit the matter to a mutually acceptable neutral  
19 third party. If the County and the Union are unable to agree on a neutral third party, an arbitrator will  
20 be selected as provided in Article 13, Section 13.2. The third party will determine whether the  
21 employee's position is appropriately classified, or if not, will determine the appropriate classification  
22 for the position within the existing classification system. The third party will not have the authority  
23 to establish new job classifications or modify an existing class specification. The decision of the  
24 neutral will be binding on the parties.

25 **Section 8.4.D Classification Revisions.** If the County adopts revisions to any  
26 classifications covered by this Agreement, the County will provide the Union with the proposed  
27 revisions and an opportunity to bargain the effects of the revisions.

28 **Section 8.5 Shift Differential.** A shift differential of \$1.00 per hour for all hours worked



1 shall apply to employees who work a regularly scheduled second shift or a regularly scheduled third  
2 shift. Employees working alternative work schedules such as referenced in Article 10, Section 2, are  
3 not eligible for shift differential unless their normal schedule is second or third shift.

#### 4 **Section 8.6 Cost of Living Adjustment**

5 A. Effective January 1, 2009, the salary in effect on December 31, 2008, for each  
6 employee in the bargaining unit shall be increased by ninety percent (90%) of the CPI-W for All U.S.  
7 Cities, September to September Index. In no event shall such increase be less than a minimum of two  
8 percent (2%) of the salary in effect on December 31, 2008, for each employee in the bargaining unit  
9 nor greater than a maximum of six percent (6%). Should King County adopt a policy implementing a  
10 new CPI Index impacting non-interest arbitration eligible employees, the Union shall be advised of  
11 such revision, and if after bargaining regarding the revision, the Union wishes to adopt such revision,  
12 it shall become part of the Labor Agreement.

13 B. Effective January 1, 2010, the salary in effect on December 31, 2009, for each  
14 employee in the bargaining unit shall be increased by ninety percent (90%) of the CPI-W for All U.S.  
15 Cities, September to September Index. In no event shall such increase be less than a minimum of two  
16 percent (2%) of the salary in effect on December 31, 2009, for each employee in the bargaining unit  
17 nor greater than a maximum of six percent (6%).

18 C. Should King County adopt a policy implementing a new CPI Index impacting non-  
19 interest arbitration eligible employees, the Union shall be advised of such revision, and if after  
20 bargaining regarding the revision, the Union wishes to adopt such revision, it shall become part of the  
21 Labor Agreement.

22 **Section 8.7 Payroll Period.** The County may implement a bi-weekly pay period for any  
23 employees covered by this Agreement. The County agrees to provide at least sixty (60) days notice to  
24 the affected employees and the Union. The County acknowledges its obligation to negotiate the  
25 effects of such implementation if the Union requests.

26 **Section 8.8 Professional Certification Premium.** Employees in the classification of Safety  
27 and Health Administrator IV who are required to hold the certification of Certified Safety  
28 Professional or Certified Industrial Hygienist, and who perform work assignments for multiple

1 County departments, shall receive a premium of seven and one-half per cent (7.5%) of regular pay for  
2 all compensated hours.

3           **Section 8.9 Application of Pay Ranges as a Result of Collective Bargaining with Other**  
4 **Unions.** Positions covered by this Agreement shall be compensated at the pay ranges as shown in  
5 Addendum A (Administrative Support Employees) and Addendum B (Professional and Technical  
6 Employees). The parties agree that should the County enter into any agreement with a union or  
7 otherwise compensate employees in the classifications listed in Addendum A and Addendum B of  
8 this Agreement at a higher salary range than that agreed upon for bargaining unit members covered by  
9 this Agreement, the Agreement may be reopened by the parties for the purpose of negotiating the  
10 application of the higher salary range for employees covered by this Agreement. The parties agree  
11 that an award of higher compensation by an interest arbitrator is specifically excluded from the terms  
12 of this Section.

1 **ARTICLE 9: OVERTIME**

2       **Section 9.1 Overtime for Extra Hours.** All work performed over forty (40) hours in any  
3 one (1) week or in excess of an overtime eligible employee’s scheduled work shift of at least eight (8)  
4 hours in one (1) day shall be considered as overtime. Overtime eligible employees whose scheduled  
5 shift is less than eight hours will receive straight-time pay for all work in excess of the shift up to  
6 eight hours, and will receive overtime pay after eight (8) hours in one day

7               **Section 9.1.1 Scheduled Day Off Overtime.** If an overtime eligible employee is  
8 required to work on a scheduled day off, the employee will be paid at the overtime rate for time  
9 worked in excess of forty (40) compensated hours in the work week.

10              **Section 9.1.2 Compensatory Time.** If the employee requests and the supervisor  
11 approves, employees may be granted compensatory time at the rate of one and one-half times  
12 overtime hours worked, in lieu of overtime pay. Employees may carry a maximum balance of 80  
13 hours compensatory time. Compensatory time may be taken as paid time off, to be requested and  
14 approved as for vacation leave. Employees may at any time request and receive a cash out of accrued  
15 compensatory time.

16              **Section 9.2 Call Back.** A minimum of four (4) hours at overtime rate shall be allowed for  
17 each call out of an overtime-eligible employee. Where such overtime exceeds four (4) hours, the  
18 actual hours worked shall be allowed at overtime rates. Shift extensions do not constitute “call outs.”  
19 Scheduled training shall not be considered “call out” when training is scheduled within one hour of  
20 the beginning or end of the employee’s work shift. Employees shall be compensated for training only  
21 for actual time spent in scheduled training.

22              **Section 9.3 Authorization of Overtime.** All overtime shall be authorized in advance by the  
23 division manager or the employee’s supervisor, except in emergencies. With respect to emergency  
24 situations, the employee shall make every reasonable effort to contact a supervisor prior to engaging  
25 in the work. Saturday and Sunday work is not overtime when it is a regularly scheduled work day for  
26 the individual.

27              **Section 9.4 Minimum Standards Preserved.** If any provision of this article conflicts with  
28 minimum standards established by Federal or State law, then that provision shall be automatically

1 amended to provide the minimum standards.

2       **Section 9.5 Standby Pay.** An overtime eligible employee assigned in writing standby status  
3 shall receive ten per cent (10%) of the employee's base hourly rate of pay for each hour on standby.

4 An employee who is not assigned in writing to standby status shall not be required to respond to  
5 cellular telephones, radios, or pagers during off-duty hours.

6       If an overtime-eligible employee who is not on standby accepts a work-related telephone call,  
7 and as a result performs a minimum of eight (8) minutes of work, the employee will be paid for  
8 fifteen (15) minutes at the overtime rate, or for the actual work time, whichever is greater. County  
9 may request documentation of the timing and nature of the telephone call. It is understood that  
10 employees who are not on call are not required to be available to respond to work-related calls during  
11 their off-duty time.

12       **Section 9.6 Overtime Assignment.** When overtime work is necessary, supervisors and  
13 managers will request volunteers from the qualified employees in the work group. If more employees  
14 volunteer than are needed for overtime work, the overtime work will be assigned to the most senior  
15 among the volunteers. If there are no volunteers or insufficient volunteers, overtime work will be  
16 assigned to the least senior among the group of qualified employees, which may include temporary  
17 employees.

18       **Section 9.7 Transportation Benefits.** The County maintains a program of transportation  
19 benefits, including a free ride home program. If the County decides to discontinue or modify the free  
20 ride home program during the term of this Agreement, the County will provide notice to the Union  
21 and an opportunity to bargain the effects.

1 **ARTICLE 10: HOURS OF WORK**

2 **Section 10.1 Workweek.** The standard work week shall consist of between thirty five (35)  
3 to forty (40) hours within a seven (7) consecutive day period, exclusive of lunch periods.

4 Any employee shall be given the opportunity to work a 35 or 40 hour work schedule and the  
5 employer shall grant such a request provided that the employee choice does not adversely impact the  
6 operation of the department or the job security of other departmental (bargaining unit) employees.

7 Any bargaining unit member who is on a 35 hour workweek prior to date of ratification may  
8 decline the employer's request for a scheduled 40 hour work week. It is understood that the employer  
9 may request employees to work in excess of the regularly scheduled hours on a temporary basis.

10 Any vacant position may be posted as a thirty-five (35) or forty (40) hour scheduled position.

11 **Section 10.2 Workday.** Generally, the working hours of each day shift shall be between  
12 6:00 a.m. and 7:00 p.m. unless the operational needs of the department or of the particular assignment  
13 dictate otherwise, or unless adjusted to accommodate alternative work schedules/flex time schedule  
14 which may be requested by employees. The establishment of reasonable work schedules is vested  
15 within the purview of the department management and may be changed from time to time; provided,  
16 that a two (2) week notice is given to all affected employees, except in exigent circumstances.  
17 Requests for work schedules will not be unreasonably rescinded or denied. The County agrees to  
18 make a good faith effort to accommodate employees' requests for alternative work schedules/flex  
19 time, consistent with efficient and effective County operations.

20 **Section 10.3 Telecommuting.** Where the County and the Union on behalf of an employee  
21 are mutually agreeable to a telecommuting arrangement, the parties shall meet and document the  
22 terms of such agreement. Such arrangements shall be in accordance with King County  
23 Administrative Policy on Telecommuting, PER 18-4 (AEP), effective October 15, 2001, and will be  
24 approved when in the best interests of the County and the employee.

25 **Section 10.4 Paid Rest Periods.** Hourly employees covered by this Agreement shall be  
26 provided with one paid, fifteen (15)-minute rest period during each half of their regularly scheduled  
27 full-time workday; or one paid fifteen (15)-minute break for a work day of five (5) hours or less. If  
28 the employee is unable to take the rest period due to work requirements the employee will be paid at

1 the overtime rate for the missed rest period time.

2       **Section 10.5 Unpaid Meal Period.** Hourly employees covered by this Agreement shall be  
3 provided with an unpaid meal time of at least one-half (1/2) hour but not more than one (1) hour  
4 during each work shift that exceeds five (5) hours. Meal periods shall be on paid time when the  
5 employee is required by the employer to remain on duty on the premises or at a prescribed work site  
6 in the interest of the employer.

7       **Section 10.6 Preservation of Designation.** An employee who elected to be designated as  
8 hourly (by exercise of the one-time option provided in the 2001-2003 Agreement Between King  
9 County and the Union Bargaining Coalition Regarding Professional and Technical  
10 Classification/Compensation to retain a 35-hour work week) is entitled to retain the hourly status (and  
11 35-hour work week if the position is reallocated to a different job class, and the employee remains the  
12 incumbent in the reallocated position. An employee who has elected to retain the hourly designation  
13 may retain the elected designation and work week when transferred at the County's initiative into a  
14 different, FLSA-exempt position. An employee who takes a different position as a result of bumping  
15 or reduction in force may be allowed at management's discretion to retain an hourly election.

1 **ARTICLE 11: MEDICAL, DENTAL & LIFE INSURANCE**

2           The County will provide a medical, dental and life insurance plan for all benefit eligible  
3 employees; such plans, including any changes thereto, to be as negotiated by the County and the  
4 Union through the Joint Labor-Management Insurance Committee.

1 **ARTICLE 12: MISCELLANEOUS**

2       **Section 12.1 Union Leave.** An employee elected or appointed to office in the Union which  
3 requires a part or all of their time shall be given leave of absence up to one (1) year without pay upon  
4 application.

5       **Section 12.2 Reimbursement for Personal Transportation.** All employees who have been  
6 authorized to use their own transportation on County business shall be reimbursed at the rate  
7 established through Ordinance by the County Council.

8       **Section 12.3 Bulletin Boards and Use of Equipment.** The employer agrees to permit the  
9 Union shop stewards and business representatives to post on County bulletin boards the  
10 announcement of meetings, election of officers, and any other Union material, providing there is  
11 sufficient space, beyond what is required by the County for “normal” business operations.

12       Union shop stewards and business representatives shall be allowed to post electronic mail  
13 notices on the County system if the notices meet the same requirements listed above. In addition,  
14 such representatives may use the County electronic mail system for communications related to  
15 contract administration. In no circumstances shall use of the County equipment interfere with County  
16 operations.

17       **Section 12.4 Union Access.** Authorized representatives of the Union may have reasonable  
18 access to its members in County facilities for transmittal of information or representation purposes  
19 before work, after work, during lunch breaks, or other regular breaks, or at any reasonable time as  
20 long as the work of the County employees and services to the public are unimpaired. Prior to  
21 contacting members in County facilities, such authorized agents shall make arrangements with the  
22 Division Manager.

23       **Section 12.5 Safety and Health.** The County agrees to comply with all applicable Federal,  
24 State and local laws and regulations regarding health and safety. In the event an employee discovers  
25 or identifies an unsafe condition, the employee will immediately notify the supervisor. Employees  
26 will not be disciplined for reporting unsafe conditions. If the Employer determines that there is an  
27 unsafe condition, it will be remedied immediately. No employee shall be required to use equipment  
28 which is not in a safe condition, or to work in an unsafe environment.



1           **Section 12.6 Bus Pass.** The County agrees to maintain the current bus pass benefit for  
2 eligible employees for the life of this Agreement.

3           **Section 12.7 Job-Related Training.** The County will pay all fees and travel expenses for  
4 required job-related training. Employees will be on paid work time when attending training required  
5 by management.

6           **Section 12.8 Personnel Records.** The County will maintain one official personnel file for  
7 each employee. The personnel file shall contain official documents of employment, promotions,  
8 discipline and other personnel and career-related records of the employee.

9           **12.8.A. Employee Access.** The employee may examine the employee's personnel  
10 file. Employees upon request may receive one copy from their personnel file copied at no cost.  
11 Material relating to job performance or personal character will be provided to the employee prior to  
12 placement in the personnel file. The employee may challenge the propriety of including it in the file,  
13 and/or submit the employee's own documentation to be attached to the challenged material.  
14 Employees may request to have materials that reflect favorably on their performance or character  
15 included in their personnel file.

16           **12.8.B. Disclosure.** Personnel records shall not be disclosed except to persons  
17 authorized under County policies, or as provided by law. An employee whose personnel file or  
18 personnel data is subject to a public disclosure demand will be notified of the demand on a timely  
19 basis, as provided in the King County Personnel Records Management Guidelines.

1 **ARTICLE 13: GRIEVANCE PROCEDURE**

2 King County recognizes the importance and desirability of settling grievances promptly and  
3 fairly in the interest of continued good employee relations and morale and to this end the following  
4 procedure is outlined. To accomplish this, every effort will be made to settle grievances at the lowest  
5 possible level of supervision.

6 Employees shall be unimpeded and free from restraint, interference, coercion, discrimination  
7 or reprisal in seeking adjudication of their grievance.

8 **Section 13.1 Definition.**

9 Grievance - A grievance shall be defined as an alleged violation of any of the express terms of  
10 this Agreement, except that verbal or written reprimands, and grievances under Article 14 (EEO) are  
11 not subject to Step 5 of the grievance procedure.

12 Other matters may arise in the course of employment that do not meet the above definition of  
13 a grievance. Employees are encouraged to discuss their concerns or potential problems informally  
14 with supervisors and/or managers. Union representatives may participate in such discussions if  
15 requested by the employee.

16 Probationary, term-limited, part-time and temporary employees shall not have the right to  
17 pursue grievances over terminations of employment but shall be able to pursue grievances as  
18 otherwise provided in this Section.

19 **Section 13.2 Procedure.**

20 **Step 1.** A grievance shall be presented in writing by the aggrieved employee (and  
21 representative, if the employee wishes) within twenty (20) working days of the occurrence or  
22 knowledge of such grievance, to the employee's immediate supervisor. The grievance statement shall  
23 include the date(s) of the alleged violation, the Article and Section of this Agreement believed to be  
24 violated, and the requested remedy. The supervisor shall gain all relevant facts and shall attempt to  
25 adjust the matter and respond in writing to the employee within twenty (20) working days. If a  
26 supervisor fails to so issue, the Union may proceed to Step 2 of this grievance procedure. If a  
27 grievance is not pursued to the next higher level within ten (10) working days after the supervisor's  
28 response, it shall be presumed resolved.

1           **Step 2.** If, after thorough discussion with the immediate supervisor, the grievance has  
2 not been satisfactorily resolved the written grievance shall then be presented to the division manager  
3 for investigation, discussion and written reply. The division manager or designee shall make a  
4 written decision available to the aggrieved employee within ten (10) working days after receipt of the  
5 written grievance statement. If a supervisor fails to so issue, the Union may proceed to Step 3 of this  
6 grievance procedure. If the grievance is not pursued to the next higher level within ten (10) working  
7 days following the division manager's or designee's response, it shall be presumed resolved.

8           **Step 3.** If, after thorough evaluation, the decision of the division manager has not  
9 resolved the grievance to the satisfaction of the parties the grievance may be presented in writing to  
10 the department director or his/her designee. All letters, memoranda, and other written materials shall  
11 be made available for the review and consideration of the department director or his/her designee.  
12 The director or designee may interview the employee and/or representative and receive any additional  
13 related evidence which may be deemed pertinent to the grievance. The director or designee shall  
14 make a written decision available within ten (10) working days after submission to Step 3. If a  
15 supervisor fails to so issue, the Union may proceed to Step 4 of this grievance procedure. If the  
16 grievance is not pursued to the next higher level within ten (10) working days after the department  
17 director or designee's response, it shall be presumed resolved.

18           **Step 4.** If, after thorough evaluation, the decision of the department director or  
19 designee has not resolved the grievance to the satisfaction of the employee, the grievance may be  
20 presented to the Director of the Human Resources Division (HRD), Department of Executive  
21 Services or his/her designee for review. The HRD Director may request information in addition to  
22 that in the grievance file, and shall determine the scope and method of review. The HRD Director or  
23 his/her designee shall render a decision within ten (10) working days of his/her receipt of the  
24 grievance file. If the HRD Director fails to so issue, the Union may proceed to Step 5 of this  
25 grievance procedure.

26           **Step 5.** Either signatory party may request arbitration within thirty (30) calendar days  
27 of the conclusion of Step 4. A request for arbitration must be submitted in writing to the King  
28 County Labor Relations Manager or designee, or to the Union representative if the County requests

1 arbitration. The arbitration request must specify:

- 2 a) Identification of section(s) of Agreement allegedly violated;
- 3 b) Details or nature of the violation;
- 4 c) Position of party who is referring the grievance to arbitration;
- 5 d) Questions which the arbitrator is being asked to decide; and
- 6 e) Remedy sought.

7 The parties shall then select a third disinterested party to serve as an arbitrator. In the event  
8 that the parties are unable to agree upon an arbitrator, then the arbitrator shall be selected from a panel  
9 of seven arbitrators furnished by the Federal Mediation and Conciliation Services or another agency if  
10 the parties agree. The arbitrator will be selected from the list by both the County representative and  
11 the Union, each alternately striking a name from the list until only one name remains. The arbitrator  
12 shall be asked to render a decision promptly and the decision of the arbitrator shall be final and  
13 binding on both parties.

14 The arbitrator shall have no power to change, alter, detract from or add to the provisions of  
15 this Agreement, but shall have the power only to apply and interpret the provisions of this Agreement  
16 in reaching a decision.

17 The arbitrator's fee and expenses and any court reporter's fee and expenses shall be borne  
18 equally by both parties. Each party shall bear the cost of any witnesses appearing on that party's  
19 behalf. Regardless of the outcome of the arbitration, each party shall bear the cost of its own legal  
20 representation.

21 No matter may be arbitrated which the County by law has no authority over, has no authority  
22 to change, or has been delegated to any civil services commission or personnel board as defined in  
23 Chapter 108, Extraordinary Session, 1967, Laws of the State of Washington.

24 There shall be no strikes, cessation of work or lockout during such conferences or arbitration.

25 **Section 13.3 Just Cause Standard.** The Employer shall not discharge, suspend, nor  
26 otherwise discipline a career service employee for other than just cause. Copies of all warning  
27 notices, suspensions and discharges shall be forwarded to the Union when issued to the employee.  
28 All disciplinary letters shall notify the employee of their appeal rights through this grievance

1 procedure and the time frame for initiating a grievance.

2       **Section 13.4 Union Representation.** In the event the Employer requires an employee to  
3 attend a meeting for purposes of questioning an employee with respect to an incident which may lead  
4 to termination of that employee, the employee shall be advised of his/her right to be accompanied by  
5 a representative of the Union and if the employee desires Union representation in said matter, he/she  
6 shall notify the Employer at that time and shall be provided a reasonable time to arrange for Union  
7 representation.

8       **Section 13.5 Extension of Timeframes.** The parties may extend the above described  
9 deadlines in writing by mutual agreement of the parties.

10       **Section 13.6 Election of Remedies.** A career service employee who is covered by this  
11 Agreement has access either to the grievance procedure herein, or the grievance procedure contained  
12 in the King County Personnel Guidelines. Selection of one procedure will preclude access to the  
13 other to resolve the grievance. Selection must be made at the conclusion of Step 1 of the procedure  
14 set forth in the Personnel Guidelines or at the conclusion of Step 2 of the grievance procedure in  
15 Article 13. The employee's selection is final.

16       **Section 13.7 Expedited Arbitration.** If both parties agree, the arbitration may be expedited.  
17 If one party desires expedited arbitration, the other party will not unreasonably withhold its consent.  
18 In conducting an expedited arbitration, the parties shall select an arbitrator and schedule the  
19 arbitration for a date no later than thirty (30) days after the issue is submitted to arbitration. The  
20 parties will not submit post-hearing briefs, and the arbitrator will be asked to issue a bench decision,  
21 but in any event will be required to issue a decision within seven (7) days of the close of the hearing.

22       **Section 13.8 Mediation.** At any step after Step 2 of this procedure, the parties may agree to  
23 request the assistance of a mutually acceptable neutral third party to serve as a mediator. This shall  
24 not preclude either party from submitting the matter to arbitration as specified in Step 5. If no  
25 arbitration request has been submitted prior to mediation, either party may request arbitration within  
26 thirty (30) days after the mediator or one of the parties declares impasse.

27       **Section 13.9 Union Right and Responsibility To Process Grievances.** The Union shall not  
28 be required to press employee grievances if, in the Union's opinion, such lack merit. With respect to

1 the processing, disposition and/or settlement of any grievance, including hearings and final decision  
2 of any arbitrator, the Union shall be the exclusive representative of the employee.

1 **ARTICLE 14: EQUAL EMPLOYMENT OPPORTUNITY**

2           The County and the Union shall not unlawfully discriminate against any individual employees  
3 with respect to compensation, terms, conditions or privileges of employment by reason of race, color,  
4 sex, religion, national origin, religious belief, marital status, age, sexual orientation, political  
5 ideology, ancestry or disability. Allegations of unlawful discrimination shall not be a proper subject  
6 for adjudication under the grievance arbitration procedure of Article 13 of this Agreement.  
7 Grievances involving allegations of discrimination that are not resolved through the grievance  
8 procedure of Article 13 may be referred by the grievant to the appropriate government agency.

1 **ARTICLE 15: SAVINGS CLAUSE**

2           Should any part hereof or any provision herein contained be rendered or declared invalid by  
3 reason of any existing or subsequently enacted legislation or by any decree of a court of competent  
4 jurisdiction, such invalidation of such part or portion of this Agreement shall not invalidate the  
5 remaining portions hereof; provided, however, upon such invalidation the parties agree to meet and  
6 negotiate such parts or provisions affected. The remaining parts or provisions shall remain in full  
7 force and effect.



1 **ARTICLE 16: WORK STOPPAGES AND EMPLOYER PROTECTION**

2       **Section 16.1 No Strike, Work Stoppage or Slowdown.** The Employer and the Union agree  
3 that the public interest requires efficient and uninterrupted performance of all County services and to  
4 this end pledge their best efforts to avoid or eliminate any conduct contrary to this objective.  
5 Specifically, the Union shall not cause or condone any work stoppage, including any strike,  
6 slowdown, or refusal to perform any customarily assigned duties, sick leave absence which is not  
7 bona fide, or other interference with County functions by employees under this Agreement and should  
8 same occur, the Union agrees to take appropriate steps to end such interference. Any concerted action  
9 by any employees in any bargaining unit shall be deemed a work stoppage if any of the above  
10 activities have occurred.

11       **Section 16.2 Union Obligation.** Upon notification in writing by the County to the Union  
12 that any of its members are engaged in a work stoppage, the Union shall immediately, in writing,  
13 order such members to immediately cease engaging in such work stoppage and provide the County  
14 with a copy of such order. In addition, if requested by the County, a responsible official of the Union  
15 shall publicly order such Union employees to cease engaging in such a work stoppage.

16       **Section 16.3 Consequences To Employee.** Any employee participating in such work  
17 stoppage or in other ways committing an act prohibited in this article shall be considered absent  
18 without leave. The County may consider such absence a resignation. Such employees are also  
19 subject to discharge, suspension, or other disciplinary action.

1 **ARTICLE 17: WAIVER CLAUSE**

2           The parties acknowledge that each has had the unlimited right within the law and the  
3 opportunity to make demands and proposals with respect to any matter deemed a proper subject for  
4 collective bargaining. The results of the exercise of that right and opportunity are set forth in this  
5 Agreement. Therefore, the County and the Union, for the duration of this Agreement, each agree to  
6 waive the right to oblige the other party to bargain with respect to any subject or matter not  
7 specifically referred to or covered in this Agreement.

8           All letters, agreements and understandings in effect prior to the effective date of this contract  
9 are deemed null and void with the effective date of this contract.

1 **ARTICLE 18: REDUCTION-IN-FORCE/LAYOFF REHIRS**

2       **Section 18.1 Seniority Definition.** Seniority for all employees in regular, career service  
3 positions as of the date of ratification is defined as total length of service in regular career service  
4 positions with King County including any service with the Municipality of Metropolitan Seattle. For  
5 purposes of layoff, bumping, and recall, the identification of affected employees shall be made on a  
6 case by case basis with seniority as the primary consideration as well as ability, skill, and experience  
7 in the job classification/position. For employees hired or transferred into positions covered by this  
8 Agreement after the date of ratification, seniority is defined as the total length of service in regular  
9 career service positions within the Administrative Support Employees, Professional and Technical  
10 Employees bargaining unit.

11       **Section 18.2 Probation Period, Temporary Service and Seniority Date.** A new employee  
12 shall be entitled to seniority when such employee has completed a probationary period of at least six  
13 (6) months with the County. Upon completion of the probationary period, the employee's seniority  
14 date shall be as provided in this Section and Section 18.1. Temporary employees and term-limited  
15 temporary employees as defined in the King County Code (KCC 3.12.010) do not obtain seniority  
16 until such time as they are hired on a regular full-time or regular part-time basis.

17           A. When an employee has previously accrued seniority in a career service position in  
18 the bargaining unit, but is on probation in another position in the bargaining unit on the effective date  
19 of a layoff, the seniority accrued in the previous position will apply for purposes of layoff, bumping  
20 and recall.

21           B. For employees in short term or term-limited temporary appointments in positions  
22 covered by this Agreement, who are appointed to a regular position without a break in service, upon  
23 successful completion of probation the seniority date shall be the first day of employment in the  
24 temporary position. In addition, an employee who has served as a term-limited temporary employee  
25 and who is subsequently appointed to a regular career service position in the same department and  
26 division within sixty (60) days of the employee's last day of service as a term-limited temporary  
27 employee will have as seniority date the first day of employment in the term-limited temporary  
28 position, provided that the employee requests such seniority date within six (6) months of

1 commencing service as a regular employee.

2       **Section 18.3 Loss of Seniority.** Seniority rights shall be forfeited if the employee is  
3 discharged for just cause or if the employee resigns employment with the County, or if the employee  
4 is on a leave of absence in excess of two (2) years in accordance with Article 7, Section 8.

5       **Section 18.4 Elimination of Positions.** The County agrees to notify the Union and the  
6 affected employee in writing at least six (6) weeks in advance of any position anticipated to be  
7 eliminated or any anticipated reduction in work hours. Seniority shall apply to layoffs pursuant to  
8 Section 1 of this Article. Such notice of layoff shall include the name, classification and seniority  
9 date of all such employees whose positions are scheduled to be eliminated. Following the  
10 consideration of other options as described below, and the exercise of bumping options as provided in  
11 this Article, the affected employees will receive the final notice of layoff not less than thirty (30) days  
12 before the effective date. Prior to laying off any employees, management shall consider the following  
13 options for the impacted employee(s):

14           A. Voluntary layoff

15           B. Voluntary retirement - pursuant to the rules of the Public Employment Retirement  
16 System.

17           C. Any other voluntary programs such as job sharing, limited hours, etc.

18       **Section 18.5 Placement.** The County will endeavor to place in other positions throughout  
19 the County those employees who are laid off. Employees who are eligible will receive referral,  
20 placement, and other services provided by the King County Career Support Services Program.

21       **Section 18.6 Bumping.** Employees who are identified for layoff by actual layoff notice, or  
22 notice of a reduction of work hours, must within three (3) work days after the employee receives such  
23 notice notify the County of their intention to bump into another position within the bargaining unit,  
24 provided such an option is available.

25       **Section 18.6.1 Eligibility to Bump.** After receiving the layoff or reduction notice,  
26 employees may displace (bump) another employee within the employee's layoff group as defined in  
27 Section 18.7 below, if they meet all of the following criteria:

28           A. The laid off employee may bump the least senior employee in the layoff

1 group who holds a position for which the laid off employee is qualified in the job classification series  
2 from which the employee is laid off, provided the employee to be bumped has less seniority than the  
3 employee who elects to bump; and

4                   B. The job classification of the employee to be bumped is at a pay range equal  
5 to or lower than the employee who elects to bump; and

6                   C. The employee electing to bump has the skill, ability and experience  
7 required to perform the work of the job classification/position pursuant to Section 1 of this Article.

8                   D. Identification of bumping options will begin with the classification from  
9 which the employee is laid off, and proceed to the next lower level if no option is available. If no  
10 bumping option is available within the laid off employee's classification series, the employee may  
11 bump the least senior employee in another classification (or lower classification in the series) covered  
12 by this Agreement in the layoff group who holds a position for which the laid off employee is  
13 qualified, provided that

14                               1. The laid off employee completed a probationary period in the  
15 classification; and

16                               2. The employee to be bumped has less seniority than the employee  
17 who elects to bump; and

18                               3. The job classification of the employee to be bumped is at a pay  
19 range equal to or lower than the employee who elects to bump; and

20                               4. The employee electing to bump has the skill, ability and experience  
21 required to perform the work of the job classification/position pursuant to Section 1 of this Article.

22                   **Section 18.6.2 Bumping Procedure.** The Employer will identify the position or  
23 positions into which a laid off employee is qualified to bump. It shall be the right of Management to  
24 determine if an employee has the skill, ability and experience required to bump into a position as  
25 stated in Article 19, Section 19.3.

26                   A. An objection to a determination by Management that an employee does not  
27 have the requisite skill, ability and experience shall be initiated at Step 2 of the grievance procedure  
28 set forth in Article 13 of this Agreement. The employee who raises such objection through the

1 grievance procedure must participate in a skills assessment by the Career Support Services program.  
2 The skills assessment will be considered by the Division Director or designee who adjudicates the  
3 employee's grievance.

4                   **B.** If more than one laid-off employee is eligible to bump into a position, the  
5 most senior among the laid off employees will have priority.

6                   **C.** Nothing in this Article shall be construed as a requirement by a laid-off  
7 employee to displace another employee. Exercise of the bumping option shall be voluntary.

8                   **D.** An employee who is notified of a bumping option must accept or decline  
9 the option within five (5) work days of being notified. If the employee does not respond within the  
10 five days, the Employer will consider that the employee has declined to bump. The employee will be  
11 advised of the five (5) day response requirement when notified of the bumping option.

12                   **Section 18.7 Layoff Groups.** For purposes of administering this Article, the following are  
13 the layoff groups in which an employee may exercise bumping rights:

14                   Layoff groups within the Department of Executive Services:

- 15                   • Finance and Business Operations Division;
- 16                   • Human Resources Division;
- 17                   • Office of Risk Management
- 18                   • Records, and Licensing Services Division;
- 19                   • Elections;
- 20                   • Facilities Management Division.

21                   The layoff group is the Department for the following:

- 22                   • Department of Natural Resources and Parks
- 23                   • Department of Transportation
- 24                   • Department of Public Health.

25                   A separate layoff group exists for:

- 26                   • Office of Information Resources Management.

27                   **Section 18.8 Bumping of Temporary Employees.** A regular employee may bump a term-  
28 limited temporary employee in a bargaining unit position within the layoff group, or may accept

1 appointment into a vacant term-limited position in the bargaining unit, provided the regular employee  
2 meets the qualifications of the position. The placement of a regular employee into a term-limited  
3 position shall not convert such position to a regular, career service position; however, at the  
4 conclusion of the term-limited appointment, such regular employee shall be entitled to all benefits of  
5 any other regular employee subject to layoff, as provided in this Article. The employee will continue  
6 to accrue seniority while in the term-limited position.

7 **Section 18.9 Recall.** All bargaining unit employees who are laid off, whose hours of work  
8 are reduced involuntarily, or who accept a position with a lower salary range, or a term-limited  
9 temporary position in lieu of layoff, shall be placed on a bargaining unit recall list. Recall to the job  
10 classification held at the time of layoff shall be by seniority pursuant to Section 1 and Section 2 of  
11 this Article. A laid off employee may be involuntarily removed from the recall list after the  
12 expiration of two (2) years from the date of layoff, or if the employee does not accept re-employment  
13 within the bargaining unit in a similar position/job classification, except for bona fide reasons.  
14 Refusal to accept re-employment in a position with a lower salary range or with fewer working hours  
15 than the employee held at the time of layoff shall not be cause for removal from the recall list.  
16 Employees who are eligible for recall may accept a temporary or term-limited position without  
17 jeopardy to their recall rights.

18 The Human Resources Division (HRD) of the Department of Executive Services shall adhere  
19 to the procedures to the County's Workforce Management Plan, except as otherwise provided in this  
20 Agreement, regarding the placement of laid off employees to positions within the bargaining unit.

1 **ARTICLE 19: POSITION OPENINGS AND JOB BIDDING**

2       **Section 19.1 Priority Job Bidding.** Prior to the initiation of any open competitive process to  
3 fill a vacant bargaining unit position (including term-limited temporary position), the County shall  
4 post a notice of the vacancy to all career service members of the bargaining unit. Any non-  
5 probationary, career service member of the bargaining unit shall be given the opportunity to compete  
6 for the vacant position.

7               **Section 19.1.1** Those employees shall be the first group of candidates to be  
8 considered for competitive appointment to the vacancy (non-competitive appointments are listed as  
9 A. through C. in Section 19.1.2 below). The appointment will be made on the basis of qualification,  
10 skill, ability, and seniority of those who are in competition for the vacancy. Should none of the  
11 bargaining unit career service candidates have the qualification, skill, and ability to perform the job,  
12 the vacancy shall then be open to other non-probationary County employees in accordance with the  
13 King County Workforce Management Plan.

14               **Section 19.1.2** Vacant bargaining unit career service positions shall be filled  
15 according to the following priority order for appointments:

16                   A. a qualified, career service bargaining unit member eligible for reassignment  
17 within the same job classification for disability accommodation; or a qualified, career service  
18 bargaining unit member on the layoff recall list for the same job classification, as provided in Article  
19 18.9 of this Agreement. When there is a reassignment candidate and a layoff recall candidate  
20 available for appointment to the same position, the most senior (as defined in Article 18, Section 1)  
21 will have priority;

22                   B. a qualified, career service bargaining unit member eligible for reassignment  
23 for disability accommodation in a different job classification;

24                   C. other qualified King County employee eligible for reassignment for  
25 disability accommodation;

26                   D. competitive bargaining unit candidates pursuant to Section 1 of this Article;

27                   E. other King County employees eligible for recall or placement, in  
28 accordance with King County Workforce Management Plan or other applicable County policies;



1 F. open competitive candidates.

2 **Section 19.2 Probationary Trial Period for Promotion and Reversion Rights.** Promoted  
3 employees who do not successfully complete their probationary period in the new position shall have  
4 the right to return to the job previously held if still vacant and available. If the position previously  
5 held is not available, the County will make a good faith effort to place the employee in an equivalent  
6 bargaining unit position for which the employee is qualified. If no such position is available, the  
7 employee may elect to be placed on the recall list for the former classification, as provided in Article  
8 18.9 of this Agreement.

9 **Section 19.3 Standards for Skill and Ability.** It shall be the right of Management to make  
10 the determination of employee qualification, skill, and ability called for in this Article and Article 18,  
11 and such determination shall be made on a reasonable basis.

1 **ARTICLE 20: DURATION**

2 This Agreement and each of its provisions shall be in full force and effect when ratified by the  
3 parties unless a different effective date is specified, and covers the period of January 1, 2009, through  
4 December 31, 2010. Written notice to begin negotiations for a successor to this Agreement shall be  
5 served by either party upon the other at least sixty (60) days prior to the expiration date; provided that  
6 the parties expressly agree to commence negotiations with respect to the Professional and Technical  
7 employees bargaining unit no later than July 1, 2010.
