7. Do you have any plans for future additions, expansion, or further activity related to or connected with this proposal? If yes, explain.

Yes. If approved, this moratorium would expire on June, 23, 2021. As background, King County Ordinance 19030 established updated regulations for winery, brewery, distillery facilities, and remote tasting rooms in unincorporated King County. Ordinance 19030 was challenged on State Environmental Policy Act and Growth Management Act grounds to the Central Puget Sound Growth Management Hearings Board. The board issued its Order of Dispositive Motions, which invalidated most of the substantive sections of the ordinance. The board remanded the ordinance to King County to take actions to bring the ordinance into compliance. Consequently, King County is working with a consultant to prepare a new SEPA checklist for Ordinance 19030. The Executive will review the environmental checklist, Threshold Determination, and public comments and determine whether amendments to the regulations are needed. If amendments are warranted, the Executive will develop and transmit legislation to the King County Council accordingly. King County may also extend the moratorium beyond the six months, if more time is needed to develop new regulations.

As noted above, King County is working with a consultant to prepare a new checklist for Ordinance 19030.

The current moratorium prohibiting the establishment of new or expansion of existing wineries, breweries, distilleries and remote tasting rooms, as primary uses or as home occupations or home industries; and prohibiting temporary use permits for wineries, breweries, distilleries and remote tasting rooms uses under the King County Code as adopted in Ordinance 19122 expires in December 2020. King County will not be able to determine if regulatory amendments are needed until the first quarter of 2021, which will be after the expiration of the moratorium. Given this timeline and that it is in the public interest to prevent unregulated winery, brewery, and distillery development until this determination has been made, this proposed legislation extends the moratorium for an additional six months as allowed by RCW 36.70A. .
