1 A MOTION authorizing the chair of the council to enter
2 into a contract amendment extending the term of the
3 contract for services to represent the county with the
4 Washington state Legislature, specifying the compensation
5 to be paid during the extended term of the contract and
6 adding terms permitting further extension of the contract
7 and requests for price changes.

8 WHEREAS, the county is a subdivision of the state of Washington, and

9 WHEREAS, as a result, the county's services, operations and finances are to a
10 significant extent controlled by the laws of the state, and

11 WHEREAS, legislation passed by the Washington state Legislature often impacts
12 King County's services, operations and finances, and

13 WHEREAS, it is in the interest of the residents of King County to have
14 representation during the legislative session on a broad range of complex issues, and

15 WHEREAS, based on a competitive solicitation process, Two Medicine
16 Communications Public Affairs Consulting was selected as the highest ranked proposer
17 and was been chosen to represent the county with state government officials, and

18 WHEREAS, the term of the county's contract with Two Medicine
19 Communications Public Affairs Consulting currently runs for one year, from January 1,
20 2011, through December 31, 2011, and

21 WHEREAS, the county has negotiated an amendment of the contract that:

22 1. Extends the contract for one additional year at the same rate of compensation,
23 not to exceed \$131,200; and

24 2. Adds language to Article II that:

25 a. Permits the extension of the contract, at the county's option, for a third year at
26 the same rate of compensation; and

27 b. Permits either party to request "[r]easonable price changes based on market
28 conditions and price/cost analysis";

29 NOW, THEREFORE, BE IT MOVED by the Council of King County:


30 The chair of the metropolitan King County council is authorized to enter into a
31 contract amendment, substantially in the form of Attachment A to this motion, extending
32 the term of the contract with Two Medicine Communications Public Affairs Consulting
33 to include the period from January 1, 2012, through December 31, 2012, for

34 compensation not to exceed \$131,200, and adding to Article II of the original contract the
35 provision entitled "Contract Extension" that is included in the proposed amendment.



- Extend the duration of services to include State Government Relations Advocacy from 1/1/2012 – 12/31/2012. The total compensation for this contract extension is \$131,200.00.
- Amend Article II of the Contract to add the language found in Section 2 of Q in RFP.

Term Service Requirement – Contract Extension

The initial contract period will be for one (1) year from the start date of the contract. The term of the contract may be extended in one (1) year increments for two (2) additional one-year periods for a total contract duration of three (3) years, in accordance with the County's best interest and at the sole option of the County. Prices shall remain firm for the duration of the contract period. Reasonable price changes based on market conditions and price/cost analysis may be requested, if such escalations are based on changes in the U.S. Department of Labor, Bureau of Labor Statistics Consumer Price Index for All Urban Consumers ("CPI-U") for the Seattle-Tacoma-Bremerton Statistical Metropolitan Area for the preceding calendar year. You may obtain information about the CPI-U in general and the Seattle area in particular by visiting the United States Bureau of Labor Statistics web site at <http://www.bls.gov/cpi>. In the event the CPI-U (or a successor or substitute index) is no longer published, a reliable government or other nonpartisan index of inflation selected by the County shall be used to calculate any adjusted amounts. Requests for any such changes are to be made in writing to the King County Council and approved by the County Executive or his/her designee. Any agreed-to change shall take effect at the time of the contract extension and shall remain in effect throughout the extension period. The parties hereto recognize that such changes could be increases or decreases in the prices; both parties are entitled to benefit from such price changes.
