Proposed ordinance 2015-0171 would reclassify Parcel No. 2022069011, which is comprised of approximately 6.5 acres, from Industrial to Rural Area with a 5 acre minimum (RA-5). Such a reclassification would result in fewer uses at a lower intensity than currently allowed. There are no development proposals or project actions associated with this downzone. Accordingly, due to the nature of the proposal, a number of questions on the checklist are inapplicable to this nonproject action; however, environmental attributes of the parcel are noted when known.
