As established by Section 350 of the King County Charter, the 6 department of judicial administration, also known as the superior court 7 clerk's office, is within the executive branch. 8 2. In accordance with K.C.C. 2.16.020, department divisions are to be 9 created by ordinance. 10 3. The department of judicial administration is not currently codified. 11 4. Codification of the department of judicial administration is desirable. 12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY: 13 NEW SECTION. SECTION 1. There is hereby added to K.C.C. chapter 2.16 a 14 new section to read as follows: 15 A. The department of judicial administration, as identified in Section 350.20.20 16 of the King County Charter, shall be managed by the superior court clerk, who shall be 17 appointed by, and serve at the pleasure of, a majority of King County superior court 18 judges. The department shall be comprised of the office of the director, the case flow 19 division, the court services division, the technology services division, the financial

23	B. The duties of the department of judicial administration shall include:
24	1. Receiving and maintaining all superior court records;

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
