King County administers the School impact Fee Program by collecting fees from residential developers on behalf of each school district that chooses to participate (the program is youndary). The fees are developed by the individ-ual school districts in accordance with provisions in state law and the King Gaunty Cade, and are sel forth in the districts' capital for lities plans.
