NOTICE IS HEREBY GIVEN, that a public hearing will be held before the Metropolitan King County Council via Zoom on the 1st day of March, 2022, at 1:00 p.m., to consider adoption of Proposed Ordinance 2022-0031, which will enable the County to sell a 1.58-acre surplus portion of the property located at 101 15th Street NE, Auburn, Washington, to the City of Auburn.

SUMMARY

King County is proposing this ordinance to sell 1.58 acres of the surplus portion of the Auburn Park and Ride facility located in King County Council District Seven to the City of Auburn for city purposes. The following is a legal description of the area:
