NOTICE IS HEREBY GIVEN that a public hearing will be held before the Metropolitan King County Council on the 22nd day of March, 2022 at 1:00 p.m., to consider Proposed Ordinance 2021-0468, relating to the condemnation of certain properties required for the Coal Creek Sewer Upgrade project. The public hearing is planned to either be held at the King County Courthouse, 516 3rd Avenue, Room 1001, Seattle, Washington; or the hearing may be required to be held remately to comply with the Washington State Governor's Declaration 20:28 (or as amended) regarding the Open Public Meetings Act. It is expected that the full Council will take action on this Proposed Ordinance at the March 22 meeting following the public testimony.
