#### **SUMMARY**

Proposed Motion 2010-0570 (pp. 3-6) would amend the Council's organizational motion to provide for Councilmember Jan Drago's successor, once his election is certified, to take Councilmember Drago's place as chair of the Regional Water Quality Committee, vice-chair of the Government Accountability and Oversight Committee, and member of the Law, Justice, Health, and Human Services Committee.

#### **BACKGROUND**

Councilmember Drago currently serves as chair of the Regional Water Quality Committee, vice-chair of the Government Accountability and Oversight Committee, and member of the Law, Justice, Health, and Human Services Committee. Upon certification of the results of the recent election, Council District 8 will have a new representative, Joe McDermott. Unless the Council acts before then, the certification of Mr. McDermott's election will create vacancies in the committee positions currently held by Councilmember Drago.

#### THE PROPOSED LEGISLATION

Proposed Motion 2010-0570 (pp. 3-6 of these materials) would amend the Council's organizational motion (Motion 11122) to provide for Councilmember Drago's successor to assume her committee positions upon certification of the election results.
