1	AN ORDINANCE approving the grant funding allocation		
2	for the projects funded through the 2020-2025 parks,		
3	recreation, trails and open space levy grant program, Round		
4	1, in accordance with Ordinance 18890, Motion 15378,		
5	Ordinance 19166 and the 2021-2022 Biennial Budget		
6	Ordinance, Ordinance 19210, Section 93.		
7	STATEMENT OF FACTS:		
8	1. Ordinance 19166 established grant award criteria and the process for the King		
9	County parks, recreation, trails and open space levy grant programs, as well as the		
10	proposed composition of advisory committees in accordance with Ordinance		
11	18890, Section 7, Motion 15378, Section F, and Attachments A, B, D and E to		
12	Motion 15378.		
13	2. Ordinance 18890, which took effect May 13, 2019, called for a special election		
14	to authorize the King County parks, recreation trails and open space levy. On		
15	August 6, 2019, King County voters approved the levy, which included funding		
16	for various grant programs including parks capital and open space, and aquatics		
17	facilities.		
18	3. The targeted equity grant program under Attachment B to Ordinance 19166		
19	will provide funding for a range of projects, including capacity building, such as		
20	community outreach and planning; land acquisition in opportunity areas or areas

21	that serve a community of need; capital projects or programs in underserved		
22	areas; and projects providing access to parks, open spaces, or recreational		
23	opportunities for people with disabilities. The goal of the program is to increase		
24	access and use of parks, open spaces, recreational facilities, and related		
25	programming in underserved areas.		
26	4. The targeted equity grants advisory committee convened in the winter of 2022		
27	to review and score grant proposals and has recommended funding for the		
28	projects listed in section 1 of this ordinance, based upon the eligibility and		
29	additional criteria set forth in Attachment B to Ordinance 19166.		
30	5. These recommendations reflect round 1 of what is expected to be a three-round		
31	grant cycle over the course of the levy. The second round of grants is expected to		
32	begin in 2023, and the third and final round of grants is expected to begin in 2024.		
33	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:		
34	SECTION 1. The King County council authorizes the funding of targeted equity		
35	grant projects for Round 1, 2022, totaling \$3,200,000, as follows:
