25	of nonsignificance on the proposed transfer dated March 9, 2022.
26	8. The utilities technical review committee reviewed the Sammamish
27	Plateau water and sewer district 2018 water comprehensive plan and found
28	that plan met the criteria for approval. The county approved the most
29	recent plan for the Sammamish Plateau water and sewer district in 2020,
30	as part of Ordinance 19069.
31	9. The county council held the legally required public hearing and has
32	considered the criteria in RCW 57.02.040.




