METROPOLITAN KING COUNTY COUNCIL NOTICE OF ADOPTION Ordinance 19550

NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing on Tuesday, November 22, 2022 beginning at 1:00 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2022-0412 (Ordinance 19550) an ordinance declaring a one-year moratorium prohibiting the acceptance of applications for the establishment of new or expansion of existing wineries, breweries, distilleries and remote tasting rooms, as primary or accessory uses or as home occupations or home industries; and prohibiting temporary use permits for wineries, breweries, distilleries and remote tasting room. The Council then adopted this Ordinance at the same meeting.

STATE OF WASHINGTON, COUNTIES OF KING AND SNOHOMISH

SUMMARY:
Ordinance 19550 enacts for one year a moratorium prohibiting the acceptance of applications for the establishment of new or expansion of existing wineries, breweries, distilleries and remote tasting rooms, as primary or accessory uses or as home occupations or home industries; and prohibiting temporary use permits for wineries, breweries, distilleries and remote tasting room. It also establishes a work plan to evaluate the next steps for the regulations regarding winery, brewery, distillery and related uses.

The notice, in the exact form annexed, was published in the regular and entire issue of said paper or papers and distributed to its subscribers during all of the said period.

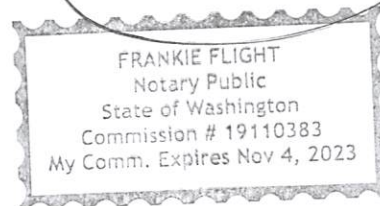
