Dear Councilmember Upthegrove:

This letter transmits the proposed first Omnibus supplemental budget Ordinance of the 2023-2024 biennium, including proposed changes to operating and capital improvement program (CIP) budgets.

The proposed legislation includes technical adjustments and reappropriations of funds for projects that were not completed in 2022, as well as proposed updates to Proviso language. Descriptions of specific operating budget items are in the narrative table included in this transmittal package.

The total proposed supplemental for operating budgets is \$322.4 million. The increase proposed for County General Fund expenditures is approximately \$45.9 million, of which \$10.1 million is revenue backed, with the remainder supported by fund balance. The total proposed increase for non-General Fund expenditures is \$276.5 million, of which \$89.1 million is revenue backed, with the remainder supported by fund balance from various funds. Included in this non-General Fund revenue is a proposal to implement a fund to provide restitution payments to victims of juvenile crime, supported by one-time funding from the federal Local Assistance and Tribal Consistency Fund.

The total capital budget appropriation included in the proposed Ordinance is \$34.3 million.

In addition, two additional proposed Ordinances are transmitted separately but concurrently with this proposed Ordinance. They are 1) a proposed Ordinance that would remove the Roads Capital Fund 3860 from the King County Code and 2) a proposed Ordinance that would amend Ordinance 19530 to allow for the cost of additional capital projects to be debt financed by issuing limited tax general obligation bonds.
