NOTICE IS HEREBY GIVEN that the Metropolitan King County Council will hold a public hearing in the King County Countil Chambers, 10th Floor, King County Courthouse, 516 3rd Avenue Room 1001, Seattle, Washington, on Tuesday November 15, 2022 at 1:00 p.m. Remote public testimony on Zoom will also be accepted. Information on the public hearing and how to submit public testimony can be found at this website: https://www.kingcounty.gov/council/committees/full\_council.aspx.

The purpose of this hearing is to consider adoption of Proposed Ordinance No. 2022-0374, which would adopt the 2023-2024 King County Capital Improvement Program (CIP). The CIP becomes the capital facilities component of the King County Comprehensive Plan and is adopted as an amendment to the King County Comprehensive Plan. The 2023-2028 King County CIP, as adopted by the County Council, will satisfy the Growth Management Act requirement to provide a six-year plan that will finance capital facilities within projected funding capacities and clearly identify sources of public money for those capisources of public money for those capital facilities.

SUMMARY
The CIP budget for the 2023-2024 biennium is \$2.66 billion. Of the \$2.66 billion, \$989 million is for wastewater treatment capital projects, \$603 million for transit capital projects, \$314 million for solid waste capital projects, \$309 million for parks and conversation capital projects, \$237 million for county facilities and information technology capital projects, \$82 million for Harborview Medical Center capital projects, \$74 million for water and land resources capital projects, and \$4 million for King County International Airport capital projects.
