c Makes a determination of the sewer rate for the year 2013 that

must be charged in order to meet the monetary require ments (administration, operating, and maintenance, repair and replacement costs) of the County's sewage disposal program. The proposed sewer rate for 2013 is \$39.85 per month per

residential customer equiva lent (RCE). By comparison, the 2012 rate is \$36.10 per month per RCE.

c Sets the capacity charge for sewer connections occurring between and including January 1, 2013 and December 31, 2013. The capacity charge is the fee that is assessed against cus tomers establishing new connections to ensure that those customers bear their equitable share of the cost of new capacity-related sewage facilities necessary to serve them. The proposed capacity charge is \$53.50 per month per RCE for fifteen years. By comparison, the 2012 capacity charge is \$51.95 per RCE per month for fifteen

years.
