## SUMMARY

Proposed Motion 2012-0260 (pp. 5-6 of these materials<sup>1</sup>) would confirm the appointment of David K. Chapman as Director of the King County Office of Public Defense.

This motion was held in committee on August 20 to allow additional time for councilmembers to meet with Mr. Chapman.

This staff report is the same as the original, except for the addition of two more letters of recommendation, which were received after the committee's August 20 meeting.

# BACKGROUND

Public legal defense services are mandated by the U.S. Constitution and the Washington State Constitution and statutes. In Washington State the cost of providing indigent<sup>2</sup> legal defense services is primarily the responsibility of local governments—counties and cities. As a regional government King County is responsible for providing indigent legal defense services for felony and juvenile defendants on a countywide basis, and as a local government the County must provide those services for misdemeanants in the unincorporated areas of the County. Cities are responsible for providing legal defense services for misdemeanors that occur within their borders.

# The King County Office of Public Defense

Indigent legal defense services in King County are coordinated by the King County Office of Public Defense (OPD), which is a division of the County's Department of Community and Human Services (DCHS). To provide those services the County contracts with four non-profit agencies:

- 1. Associated Counsel for the Accused (ACA);
- 2. Northwest Defenders Association (NDA);
- 3. Society of Counsel Representing Accused Persons (SCRAP); and
- 4. The Defender Association (TDA).

OPD administers those contracts and is responsible for preparing an annual budget for the County's public defense program. In addition, OPD is responsible for maintaining a list of lawyers, known as the Assigned Counsel Panel, who are available to handle cases that the four agencies cannot accept because of a conflict of interest.

Ordinance 17189, adopted by the Council in September 2011, included the following changes related to OPD:

**1. Appointment of OPD Director.** The County Executive, rather than the DCHS director, now appoints the OPD director, though OPD remains a division of DCHS and reports to the DCHS director. The appointment continues to be subject to Council confirmation.

**2. Name of the Office.** The name of OPD has been changed from the "Office of the Public Defender" to the "Office of Public Defense".

**3. Title of the OPD Director.** The head of OPD is now known as the "Director of the Office of Public Defense" instead of the "Public Defender."

**4. Director Selection Process.** The Executive now consults with representatives of the criminal justice system and the broader community during the recruitment and selection of the OPD director, rather than convening an advisory committee to assist the DCHS director in the appointment process.

**5. Director Qualifications.** Ordinance 17189 changed the required skills and duties of the director of Public Defense. The Public Defender had been required to be a licensed attorney with prior experience in public defense and management. Ordinance 17189 revised the requirement, providing that the director of the Office of Public Defense must "ensure the office of public defense employs the needed technical and public defense expertise to ensure effective delivery of public defense services."

# Appointment of David K. Chapman as OPD Director

On 21 June 2012, following a national search, the Executive appointed David K. Chapman as OPD director, effective 30 July 2012. (Appointment letter, pp. 21-22)

# MR. CHAPMAN'S QUALIFICATIONS

In a July 6 press release announcing his appointment of Mr. Chapman (pp. 9-10), the Executive cited Mr. Chapman's "more than 30 years [of] experience in the King and Pierce County justice systems" and said: "Dave Chapman's great breadth of knowledge

and his first-hand experience with so many aspects of the criminal justice system—as a judge, as a prosecutor, as a public defender, and as a private attorney—make him uniquely qualified to lead our office of public defense through the coming years." Additional details are provided in the Executive's transmittal letter (pp. 7-8).

Mr. Chapman received his law degree (J.D.) in May of 1981 from the University of Puget Sound Law School (now the Seattle University School of Law) and his undergraduate degree (B.A.) in June of 1978 from Western Washington University.

Mr. Chapman's work experience, which is detailed in his resume (pp. 19-20), is summarized below:

- 2008 present: Sole Practitioner, Criminal Defense Litigation, Seattle;
- 1999 2008: Managing Director, Associated Counsel for the Accused (ACA), Seattle;
- 1986 1999: Tracy, Tracy and Chapman, Attorneys at Law, Criminal Defense Litigation, Tacoma;
- 1986 1999: Pro-Tem Judge, Pierce County and King County District Courts;
- 1982 1986: Public Defender and Misdemeanor Supervisor, Associated Counsel for the Accused, Seattle;
- 1982: Deputy Prosecuting Attorney, Pierce County Prosecutor's Office.

In his role as Managing Director of ACA, according to the transmittal letter (p. 7):

[Mr. Chapman] oversaw the daily affairs of over 100 public defense attorneys and prepared annual budgets and revenue-to-expense reports to comply with all government contracting requirements. He successfully collaborated with executive agencies, county and city governments, law enforcement, corrections, probation, prosecution, and the courts in the performance of his duties.

In addition, Mr. Chapman "has published numerous articles on a wide range of issues related to the criminal justice system" (Transmittal letter, p. 7).

# Executive appoints experienced criminal defense lawyer to head Office of Public Defense David K. Chapman brings 30 years criminal justice experience to new position as public defense director; County Council must confirm

A well regarded local attorney with more than 30 years experience in the King and Pierce County justice systems has been named today by King County Executive Dow Constantine to head the County's Office of Public Defense.

"Dave Chapman's great breadth of knowledge and his first-hand experience with so many aspects of the criminal justice system – as a judge, as a prosecutor, as a public defender, and as a private attorney – make him uniquely qualified to lead our office of public defense through the coming years," said Executive Constantine.

The appointment of David K. Chapman, which comes at the completion of a national search, is subject to confirmation by the Metropolitan King County Council. The Office of Public Defense is a division within the Department of Community and Human Services (DCHS). He will work closely with the County Executive.

"I am excited about the opportunity to serve King County as the Director of the Office of Public Defense," said Chapman. "King County has shown a strong commitment to providing access to justice and appointing counsel for those who could not afford it. I look forward to working within the King County justice system to continue to improve our delivery of public defense services."

Mr. Chapman began his legal career in 1982 as a Deputy Prosecuting Attorney with the Pierce County Prosecutors Office. He left that position to join the Associated Counsel for the Accused (ACA), a nonprofit firm that contracts to provide defense services to indigent clients, including a contract for public defense services with King County. He worked as a public defense attorney and misdemeanor supervisor. He left ACA in 1986 to work in private practice and serve as a Pro-tem Judge for both Pierce and King County, where for 13 years he presided over both criminal and civil cases in District and Municipal Courts. Mr. Chapman returned to ACA in 1999-2008 to serve as Managing Director for the agency, responsible for managing 100+ attorneys, developing annual budgets and revenue-to-expense reports, and collaborating with partners on system-wide criminal justice issues.

"Dave Chapman is an experienced public defender, manager and trial lawyer who will provide great leadership for the Office of Public Defense," said King County Superior Court Judge Michael J. Trickey.

Most recently, Mr. Chapman has been a private practice attorney assisting persons charged with misdemeanor, gross misdemeanor and felony offenses. He is an accomplished legal practice educator and trainer, and has published numerous articles on a wide range of issues related to the criminal justice system.

"David's longtime experience working within the criminal justice system of King County makes him an excellent choice to head up our office of public defense and I look forward to working with him," said Metropolitan King County Council Chair Larry Gossett.

Mr. Chapman is a resident of Vashon who earned his law degree from Seattle University School of Law in 1981. His appointment as director for OPD begins July 30, 2012.


