NOTICE IS HEREBY GIVEN that the Metropolitan King County Council will consider Proposed Motion 2012-0403, identifying a project to be funded under Public Law 106-393, Title III, the Secure Rural Schools and Self-Determination Act of 2000, and allocating to that project the funds to be received from the federal government for federal fiscal year 2012. Comments from the public on the motion will be accepted until November 17, 2012.

Summary

Proposed Motion 2012-0403 proposes to use 2012 Title III funding to continue the Firewise Forests Initiative in the Water and Land Resources Division Forestry Program, which will assist rural communities to develop Community Wildfire Protection Plans, and to promote the use of practices that reduce the risk of wildfire.
