SUMMARY

Proposed Motion 2012-0306 (pp. 3-4 of these materials¹) would confirm the appointment of Garmon Newsom to the King County Board of Ethics.

THE KING COUNTY BOARD OF ETHICS

The King County Board of Ethics was created by Ordinance 1321 in 1972 "to insure proper implementation of the code of ethics and to investigate and report on conflicts of interest." The board consists of five members: two to be appointed by the county executive, two to be appointed by the county executive from a list of nominees submitted by the county council, and a fifth member, who serves as chair and is appointed by the county executive from a list of nominees submitted by the other four members. Each member serves a term of three years. All appointments to the board are subject to confirmation by the Council.

GARMON NEWSOM

Proposed Motion 2012-0306 would confirm the Executive's appointment of Garmon Newsom, effective 1 August 2012, to serve on the Board of Ethics for a three-year term expiring on 31 July 2015.

Mr. Newsom, who resides in Council District 6, has served since May of 2005 as Assistant City Attorney for the City of Renton, where his responsibilities have included civil and criminal litigation, advising city officials on law and procedure, reviewing contracts, and drafting ordinances, among other things. His experience also includes service as Executive Agency Counsel with the New York City Transit Authority, Assistant District Attorney in Bronx County, New York, and Assistant District Attorney with the New York City Special Narcotics Prosecutor.

Mr. Newsom received his B.A. degree in Political Science from Morehouse College in Atlanta, Georgia, and his law degree from the George Washington University Law School in Washington, D.C.
