SUMMARY

The 2013-2018 CIP budget calls for capital authors of about \$2.64 billion over the next six years. Of that budget authority, approximately \$54.7 million is assumed for expenditure in 2013, with \$46.3 million for expenditure in 2013, with \$46.3 million for general government capital programs and \$8.5 million for maior maintenance projects. 2.The Environmental Sustainability Area includes programs for safeguarding and enhancing the county's natural resources and environment. This category includes wastewater treatment, solid waste, flood and surface water, and open space acquisition.

3. The General Government Area reflects how the county provides services to the public. These services include lease costs for county agencies, facility capital improvements, Harborview Medical Center and technology improvements for King County agencies.
