1	AN ORDINANCE authorizing the King County executive
2	to enter into amendments to interlocal cooperation
3	agreements with the cities of Bellevue, Bothell, Issaquah,
4	Kenmore, Kent, Renton and Seattle for the disbursement of
5	conservation futures tax levy funds appropriated under
6	Ordinance 17476.
7	STATEMENT OF FACTS:
8	1. King County conservation futures tax levy funds are collected
9	throughout King County as a dedicated portion of the property tax for the
10	acquisition of open space and resource lands.
11	2. Ordinance 14714 established procedures for the annual allocation of
12	conservation futures tax levy funds, which direct the conservation futures
13	citizens' committee to make funding recommendations to the King County
14	executive to consider for inclusion in the annual budget ordinance.
15	3. The executive received and considered the conservation futures
16	citizens' committee funding recommendations and has included them in
17	the 2013 budget ordinance, Ordinance 17476, in which the King County
18	council appropriated 2013 conservation futures funds to the city open
19	space projects listed and described in Attachment B to this ordinance.

20	4. For King County to disburse 2013 conservation futures collections to
21	the suburban cities and the City of Seattle, it must sign conservation
22	futures interlocal cooperation agreements or amend existing conservation
23	futures interlocal agreements with these jurisdictions.
24	5. The county and the cities are authorized to enter into an interlocal
25	agreement pursuant to chapter 39.34 RCW, the Interlocal Cooperation Act.
26	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
27	SECTION 1. The King County executive is hereby authorized to enter into and
28	execute amendments to interlocal cooperation agreements containing language,

- 29 substantially similar to that in Attachment A to this ordinance, necessary for the
- 30 disbursement of conservation futures tax levy funds appropriated under Ordinance 17476.

# AMENDMENT TO THE CONSERVATION FUTURES INTERLOCAL COOPERATION AGREEMENT BETWEEN KINGCOUNTY AND THE CITY OF FOR OPEN SPACE ACQUISITION PROJECTS

#### **Preamble**

The King County Council, through Ordinance 9128, has established a Conservation Futures Levy Fund and appropriated proceeds to King County, the City of Seattle and certain suburban cities. This amendment is entered into to provide for the allocation of additional funds made available for open space acquisition.
THIS AMENDMENT is entered into between the CITY OF and KING COUNTY, and amends and attaches to and is part thereof of the existing Interlocal Cooperation Agreement entered into between the parties on the day of (Month), (Year), as previously amended.
The parties agree to the following amendments:
Amendment 1: Article 1. Recitals
A paragraph is hereby added to the Recitals Section to provide for a Conservation Futures Levy Fund allocation for the Acquisition, and hereafter reads:
On, 201_ the King County Council passed Ordinance, which appropriated a total of (\$) in Conservation Futures Levy proceeds to the City of for the acquisition Project. On, 201 The King County Council passed Ordinance, authorizing the King County Executive to enter into interlocal agreements with the City for the disbursement of Conservation Futures Funds appropriated in Ordinance
Amendment 2: Article V. Conditions of Agreement
Section 5.1 is amended to include Attachment, which lists a 201_Conservation Futures Levy Allocation for the Acquisition project.
Amendment 3: Article VII. Responsibilities of County
The first two sentences of this article are amended to include references to Attachment, whic ists a 201_ Conservation Futures Levy proceeds allocation for the Acquisition Project:
Subject to the terms of this agreement, the County will provide Conservation Futures Levy Funds in the amounts shown in Attachments A through

additional funds; however, the County has no obligation to provide funds to the City for the Projects in excess of the total amounts shown in Attachments A through \_\_\_. The County assumes no obligation for the future support of the Projects described herein except as expressly set forth in this agreement.

#### **AMENDMENT 4: Attachment**

The Attachments to the interlocal agreement are hereby amended by adding Attachment \_\_\_, which is hereby attached to the interlocal agreement, incorporated therein and made a part thereof.

In all other respects, the terms, conditions, duties and obligations of both parties shall remain the same as agreed to in the Interlocal Cooperation Agreement as previously amended.

This document shall be attached to the existing Interlocal Cooperation Agreement.
