1. Amendments to 2013 Budget & 2013/2014 Biennial Budget

Goal: Review and make recommendations to the full Council on all proposed ordinances amending the 2013 budget ordinance & 2013/2014 biennial budget ordinance.

Key Work Program Items:

- Review up to four quarterly omnibus budget supplemental ordinances;
- Review "stand-alone" budget supplementals;
- Track and report on budget, provisos and responses;
- Develop a work program for a major biennial budget update and present the committee with various options.

2. Financial Analysis and Budget Monitoring

Goal: Review financial reports, budget reports, financial plans and other documents in order to track budget ordinance and policy compliance, financial conditions, operating results, reserve status, and other financial issues.

Key Work Program Items:

- Review quarterly management and budget reports from Office of
- Performance, Strategy and Budget;
- Review other reports and documents in order to track financial condition of major funds.

3. Debt and Investment Proposals

Goal: Make policy recommendations to the full Council on proposals for the issuance of short or long-term debt, refunding of bonds or investments of public funds.

Key Work Program Items:

- Consider all agreements related to the construction, purchase, or financing of an arena and any other agreements to attract professional sports franchises to King County.
- Review and pass on to the full Council ordinances that authorize the issuance of new debt or the refunding of existing debt;

- Attend monthly Executive Finance Committee meetings to review and approve investment policies and interfund loans and monitor investment and interest earnings results and projections;
- Propose new investment policies as appropriate

4. Levies, Fees and Taxes

Goal: Make policy recommendations to the full Council on proposals to implement new fees, charges, levies or taxes or to change existing fees charges, levies or taxes.

Key Work Program Items:

- Review all tax, levy and fee proposals. Including, but not limited to:
 - o 2014-2019 Parks Levy
 - o 2014-2019 Parks Expansion Levy (if proposed)
 - o 2014-2019 Emergency Medical Services Levy
 - o 2013 Capacity Charge Update
 - o 2013 Extension of Solid Waste Contracts (if successfully negotiated)

5. Property Management and Related Policy Direction

Goal: Review and make recommendations to the full Council on all proposed property decisions involving sale and lease of real property to or by the County.

Key Work Program Items:

- Review of proposed surplus properties;
- Review proposed sales or leases of county owned property;
- Review proposed purchases or leases of property by the county;
- Review work plans for future use of capital facilities.
