1 A MOTION appointing a committee to write the voters'
2 pamphlet statement for the November 5, 2013, general
3 election regarding Ordinance 17614 providing for the
4 submission to the qualified electors of King County at a
5 general election to be held in King County on November 5,
6 2013, of a proposition authorizing the creation of an
7 appointed office of county public defender, a department of
8 public defense and a public defense advisory board,
9 permitting the county to contract for public defense
10 services and requiring the executive to consult with the
11 county public defender on the executive's bargaining with
12 employees of the department of public defense.

13 WHEREAS, K.C.C. chapter 1.10 provides for the publication and distribution of
14 local voters' pamphlets in conformity with chapter 29A.32 RCW for annual general
15 elections held in King County, and

16 WHEREAS, RCW 29A.32.280 provides that, for each measure from a unit of
17 local government that is included in a local voters' pamphlet, the legislative authority of
18 that jurisdiction shall formally appoint a committee to prepare arguments advocating

19 voter approval of the measure and a committee to prepare arguments advocating voter
20 rejection of the measure, and

21 WHEREAS, Ordinance 17614 provides for the submission to the qualified
22 electors of King County at a general election to be held in King County on November 5,
23 2013, a proposition authorizing the creation of an appointed office of county public
24 defender, a department of public defense and a public defense advisory board, permitting
25 the county to contract for public defense services and requiring the executive to consult
26 with the county public defender on the executive's bargaining with employees of the
27 department of public defense;

28 NOW, THEREFORE, BE IT MOVED by the Council of King County:

29 The following individuals are appointed to serve on the voters' pamphlet
30 committee to write a statement for and against the proposition authorizing the creation of
31 an appointed office of county public defender, a department of public defense and a
32 public defense advisory board, permitting the county to contract for public defense
33 services and requiring the executive to consult with the county public defender on the


